As Per Directions given by Hon'ble Supreme Court Committee on Road Safety vide letter no- 30/CoRS/2014 (Vol 5) Dated-27-02-2020 and in exercise of the power conferred in rule-31 of Bihar Road Safety Council Rules 2018, amendment is being done in Rule 22 Sub Rule (3)(a) of the English Version of Bihar road safety council rule, 2018 as follows:-

22 (3)(a) The Co-Ordination Committee of Transport - This Committee shall be constituted in the Transport Department, and its functions shall ensure:-

- (i) To formulate sub policies under Bihar Road Safety policy.
- (ii) To prepare Bihar Road Safety work plan and amending from time to time
- (iii) This coordination committee shall be responsible for budgetary provisions of Road Safety fund.
- (iv) Legislative reforms related to the issue of road safety in the transport sector.
- (v) To formulate safe school bus policy and monitor its implementation.
- (vi) To develop, monitor and implement road safety publicity campaign including Road Safety Week annually.
- (vii) Monitoring the implementation of driving training schools, computer based driving test centers and technological upgradation related to improving these facilities.
- (viii) To ensure active participation of Panchayati Raj Institutions, Urban Local Bodies and NGOs in road safety awareness program.
- (ix) To monitor the implementation of all road safety measures as provided in the Motor Vehicles Act, 1988 and directed by the Supreme Court/High Court from time to time.
- (x) Any other work directed by the Government/Council.
