Minutes of review meeting on ROBs held on date- 17.03.2023 at 3:30 PM through VC under Chairmanship of Chief Secretary, Bihar, Patna.

Meeting started by reviewing action taken report on the directions given during last review meeting dated 23.01.2023, Agenda discussed as follows:

1) *Reduction in D&G (Direction & General) Charges by Railway*

Railway has reduced D&G charges from 10.63% to 6.89% for civil works and intimated that total D&G charges will be paid to executing agency and Railway will forego its share. File sent to Finance Department, Bihar for concurrence. RCD has been directed to follow up with Finance department.

2) *Sonepur – Parmanandpur, LC -01/A*

ROB is not feasible due to site constraint. Railway has proposed Low Height Subway. Railway informed to RCD that consent for LC closure has been given by DM Saran.

3) *Patna-Sachiwalaya Halt, LC-30/A*

Two ROBs exists within 1.00 km distance; On east side, Bhikari Thakur ROB exists at 550m away and on west side, another ROB exists at 690m away from Road No. 15. Hence this ROB is not feasible due to site constraints. FOB with ramp is only feasible at this location.

4) *Bagaha-Valmikinagar Road, LC-59*

This LC lies in Valmiki Tiger Reserve Forest, A bypass is already proposed by Ministry of Road Transport & Highways. After construction of Bypass, the traffic through this LC will become negligible.

5) *LC No. 39, LC No-32, LC-61 spl, LC-24, LC-137, LC-49, LC-7B, LC-67A, LC-59, LC-2, LC-10, LC-33B, LC-33, LC-4A, LC-7Spl, LC-100 Spl, LC-53A, LC-32A, LC-26, LC-36, LC-29, LC-53/1/C, LC-55, LC-51, LC-40/B/T*

DPRs of the remaining 25 LCs is pending for submission due to revision of D&G charges by Railway. DPR will be submitted after getting consent from Finance Department.

- 6) **LC No.-121 (Motipur Yard), 55 (Sitamarhi- Parsauni), 104 (Saharsa-Baijnathpur) & LC No.-54 (Barh-Athmalgola)**

RCD requested to Railway to take up above these LCs under new policy of railway board letter no.2017/CE-IV/LX /Misc/244 (LCs) Pt. dt. 02.03.2023

- 7) **LC No.-54(Sitamarhi- Parsauni), 39(Danapur-Neora), 145(Muzaffarpur-Sugauli), 184(Majhulia-Bettiah)**

These LCs are lying on RWD road.

- 8) **LC No.-50(Taal-Mokama)**

This LC lies on road of Urban Development and Housing Department.

- 9) **LC No. 33 & 34 of Raxaul Yard**

Direction has been given to conduct a joint survey of Railway and BRPNNL for approval of GAD.

- 10) **LC No. 23B (Goraul-Kurahani)**

Railway requested to BRPNNL to submit GAD at the earliest.

- 11) **LC No. 71A (Gaya-Manpur) & LC No. 4A (Gaya-Kastha)**

Railway requested to BRPNNL to submit GAD without provision of FoB.
