2	Out of above 46 ROBs, 31 DPRs on revised D&G charges are to be submitted by RCD.	It was stated by RCD all balance DPRs will be submitted within next 15 days.																																							
3	These are 12 ROBs which are not covered under MoU dt 07.05.2019. In almost all of these, work in Railway portion is either complete or near to complete. Approved work in 2 ROBs (11B & 19B) is being executed by BSRDC & in 10 ROBs by BRPNNL. Work in approaches to be expedited by State Govt.
