15. (A) Bid processing fee and cost of BOQ (Non Refundable) is mandatory to be paid through on line mode (e payment mode) i.e. internet payment Gateway (Credit / Debit card). Net Banking NEFT / RTGS under e – Tendering / e-procurement system.  
 (B) EMD will be acceptable either online mode (e-payment mode) or Physical mode/Manual payment system under e-Quotationing/e-Procurement system. Under on-line mode EMD may be made through Internet Payment Gateway (Credit/Debit Card) Net Banking, NEFT/RTGS. Under Physical mode/Manual payment system, Earnest money duly pledged/endorsed to the Executive Engineer (Mech.), Irrigation Mechanical Division, Mohania should be in following shapes or combination there of :-

16. Submission of Notorised Affidavit for this specific work, issued in between the date of NIQ and last Date for uploading the quotation, in the format as per the Annexure-3 of the Water Resources.



17. Department letter no. 536 dated 13.06.2013 is mandatory. In case of Joint Venture, the bidder shall have to full fill the criteria laid down in the Annexure-2 of the Water Resources Department letter no. 536 dated 13.06.2013.

21. The Quotationers should fully satisfy of Download ability/Visibility of scanned uploaded documents.
22. No claims shall be entertained on account of disruption of internet service being used by Quotationers. Bidders are advised to up load their bids well in advance to avoid last minute technical snags.

In the unlikely event of the server of [www.eproc.bihar.gov.in](http://www.eproc.bihar.gov.in) remaining down for more than two consecutive hours during interval from 12.00 O'clock (midnight) to last time for uploading quotation on the last day, the last date for uploading the quotation will automatically extended to next working day till the last time fixed for uploading the quotation.
24. One percent cess for labour welfare, GST & other taxes will be deducted from the contractor bill as per rule.
25. Quotationer must be Registered in GST and attached Registration Certificate with Quotation.
26. Conditional Quotation will be rejected.
27. Quotation decision will be done as per provisions contained in the updated Circular/letters issued by Water Resources Department.
28. Estimated cost may increase or decrease. Earnest money will be submitted accordingly.
