- 1. This Invitation for Bid follows the General Procurement Notice for this Project that appeared in Development Business on 9th March, 2017.
- The Government of India has received financing from the World Bank towards the cost of National Hydrology Project and intends to apply a part of the funds to cover eligible payments under the contracts for construction of works as detailed below.
- Bidding will be conducted through National Competitive Bidding procedures agreed with the World Bank. Bidding is open to all eligible bidders as defined in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers (January 2011, revised July 2014).
- 4. Bidders from India should, however, be registered with the Government of Bihar or other State Governments/Government of India, or State/Central Government Undertakings. Bidders from India, who are not registered as above, on the date of bidding, can also participate provided they get themselves registered by the time of contract signing, if they become successful bidders. Bidders are advised to note the clauses on eligibility (Section I Clause 4) and minimum qualification criteria (Section III – Evaluation and Qualification Criteria), to qualify for the award of the contract. In addition, please refer to paragraphs 1.6 and 1.7 of the World Bank's Guidelines setting forth the World Bank's policy on conflict of interest.
- 5. The Chief Engineer, Flood Control & Drainage, Water Resources Department, Patna, *Government of Bihar* invites online bids for the construction of works detailed below in the table.

Bidders will be required to register in the website, which is free of cost. The bidder would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.

- 7. The bid document is available online and bids are to be submitted online through the e-Procurement portal <u>https://eprocure.gov.in</u> only. Bids submitted in any other manner will not be accepted. Bidders are required to obtain Digital signature Certificate (DSC) from the authorized Certifying Authorities Portal and then register with the e-procurement platform and submit bids by using their user ID-and Digital Signature.
- 8. Bids security of the amount specified in the bidding document, drawn in favour of Water and Land Management Institute, Patna payable at Patna must be submitted as per the procedure described in paragraph 10 below. The Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid.
- 9. Bids must be submitted online on http://eprocure.gov.in on or before the date and time for receipt of bids, and the 'Technical Part' of bids will be opened online on the specified time and date for opening of bids, as given above. The "Financial Part" shall remain unopened in the e-procurement system until the second public Bid opening for the financial part. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time. The electronic bidding system would not allow any late submission of bids.
- The bidders are required to submit following documents in original before date and time fixed for bid submission: -
- (a) Original demand drafts towards the cost of bid document and registration on e-procurement website (if not previously registered);
- (b) Original bid security in approved form specified in the bid document
- (c) Authorization letter from bidder for the person who will participate at the time of opening of the bid; and
- (d) Original affidavit regarding correctness of information furnished with bid document with the Executive Engineer, Punpun Flood Protection Division, Anisabad, Patna before the opening of the technical part of the Bid given above, either by registered post/speed post/courier or by hand, failing which the bids will be declared non-responsive and will not be opened.

Note: - If the office happens to be closed on the date of Submission of the bids as specified, the said original documents shall reach the designated officer at the same time on the next working day. In case of failing in submission of above (a) & (b) before deadline, bidder will be declared non-responsive.

- 11. A pre-bid meeting will be held on 14/10/2019 at 11.30 hrs. in the Office of the Chief Engineer, Flood Control and Drainage, Patna, Water Resources Department, Government of Bihar, 1st Floor-Jal Sansadhan Bhawan, Block-A, Anisabad, Patna-800002 to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITB Clause 7.4 of 'Instructions to Bidders' of the bidding document. Bidders are advised to download the bidding document prior to the pre-bid meeting in order for bidders to have a good understanding of the scope of work under this contract for discussion and clarification at the pre-bid meeting.
- 12. Other details can be seen in the bidding documents. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to this bid.
