This is done by the comparing official records with actual ground realities with the participation of the community in the verification exercise and reading out the finding of the verification exercise aloud in a public platform. Oral testimonies and facts are obtained from the public and compared with the official records. The Social audit process also examines whether the money was spent properly and has made a difference to people's lives.

This society will conduct social audit of different programme/schemes of Rural Development Department, Bihar primarily MGNREGA, Indira Awas Yojna/ Pradhan Mantri Awas Yojna, and Lohiya Swachh Bihar Abhiyan (SAS). In addition to this, society will do social audit for Food and Consumer Protection Department, Bihar.
