The Govt. of Bihar has established a three Member Bihar Electricity Regulatory Commission having a Chairperson and two Members. The Commission shall regulate the Electricity industry in the State of Bihar under the provisions laid down in the Electricity Act, 2003. The Selection Committee has been constituted in the terms of the Electricity Act, 2003. The one post of Member of BERC is likely to be vacant.

- 2. I am directed to invite proposals and nominations of candidates for consideration of the Selection Committee for post of one Member of the Bihar Electricity Regulatory Commission. The nominees should be persons of ability, integrity and standing having adequate knowledge and experience of, and have shown capacity in dealing with problems realiting to Engineering finance, Commerce, Economics, Law or Management. U/S 84 of the electricity Act, 2003.
- 3. The terms of appointments will be in general accordance with the provisions of The Electricity Act, 2003 and including the following:-
- (i) The person appointed would have to resign or opt for voluntary retirement from the service to which he/she belongs.
- (ii) The Member would hold office, for a term of five years from the date he enters upon his office, but shall not be eligible for re-appointment in the same capacity in the Commission.

Provided that no Member shall hold office as such after he has attained the age of sixty-five years.

- (iii) Any Member in the Commission shall-
- (a) Not accept any commercial employment for a period of two years from the date he ceases to hold office.
- (b) Not represent any person before the Central Commission of any State Commission in any manner.
- 4. The pay of the post of Member carries of Rs. 1,82,200/- per month. The allowances payable and the other terms and conditions of service of the Member shall be as prescribed by the State Govt. Bihar Electricity Regulatory Commission (Conditions of Services of Chairman and Member) Rules, 2003.
