## **Government of Bihar**

### **Department of Energy**

The Govt. of Bihar has established a three Member Bihar Electricity Regulatory Commission (BERC) having a Chairperson and two Members. The Commission shall regulate the Electricity industry in the State of Bihar under the provisions laid down in the Electricity Act, 2003. The Selection Committee has been constituted in the terms of the Electricity Act, 2003. The one post of Member (Law/Judicial) of BERC is likely to be vacant.

2. I am directed to invite proposals and nominations of candidates for consideration of the Selection Committee for post of one Member (Law/Judicial) of the Bihar Electricity Regulatory Commission. The nominees should be persons of ability, integrity and standing having adequate knowledge and who is, or has been holding a judicial office or is a person possessing professional qualifications with substantial experience in the practice of law, who has the requisite qualifications to have been appointed as a judge of the High Court or a District Judge.

3. The terms of appointments will be in general accordance with the provisions of The Electricity Act, 2003 and including the following:-

(i) The person appointed would have to resign or opt for voluntary retirement from the service to which he/she belongs.

(ii) The Member would hold office, for a term of five years from the date he enters upon his office, but shall not be eligible for re-appointment in the same capacity in the Commission.

Provided that no Member shall hold office as such after he has attained the age of sixty-five years.

(iii) Any Member in the Commission shall-

(a) Not accept any commercial employment for a period of two years from the date he ceases to hold office.

(b) Not represent any person before the Central Commission of any State Commission in any manner.

4. The pay of the post of Member carries of Rs. 1,82,200/- per month. The allowances payable and the other terms and conditions of service of the Member shall be as prescribed by the State Govt. Bihar Electricity Regulatory Commission (Conditions of Services of Chairman and Member) Rules, 2003.

5. The nomination should contain the following:-

(i) Bio-data of proposed candidate containing the following details:-



- (a) Name
- (b) Age & date of Birth
- (c) Position presently held
- (d) Educational Qualification
- (e) Details of post previously held and experience in the relevant field.

(ii) Willingness letter to resign his/her present post to join Bihar Electricity Regulatory Commission (BERC), if selected.

(iii) A letter from the proposed intimating the details of any office, employment of Consultancy agreement of arrangement with he/she has in his/her own name or in any firm, association of persons or body corporate, or in the name of any relative, carrying on body corporate, or in the names of any relative, carrying on any of the following business, namely:-

- (a) Generation, transmission, distribution or supply of electricity.
- (b) Manufacture, sale or supply of any fuel for generation of electricity.
- (c) Manufacture, sale, lease, hire or otherwise, supply of or dealing in machinery, plant, equipment, apparatus or fitting for the Generation, transmission distribution, supply or use of electricity and,
- (d) Any entity providing professional services to any of the business referred to in clauses (a), (b) and (c) above.

6. The nominations as indicated above are to be sent by speed post/courier to the Principal Secretary, Energy Department, Govt. of Bihar, Daroga Prasad Rai Path. Patna-800001. The nominations may be submitted on or before **10 July, 2023 at 4:00 P.M.**
