INSTRUCTIONS TO BIDDERS

BREDA intends to undertake a single stage [three envelope system] registration process in order to shortlist and qualify suitable Manufacturers.

1. The Manufacturers shall furnish, Payment of Application Fee in **Envelope-I** i.e., **Non-Refundable** INR 11,800.00 (Including GST 18%) to be paid through (Demand Draft (DD) in favor of “**Bihar Renewable Energy Development Agency**” payable at “**Patna**”.
2. **Envelope- II** contains the technical document including other required certificates/ documents as mentioned in check-list.
3. **Envelope- III** will contains both envelope i.e. envelope-I and envelope-II.
4. Also, on each envelope it should clearly mention the name of documents it contains.
5. **However each envelopes should be duly sealed and stamped with and respective Envelop number. Document not found in prescribed format will not be acceptable.**
6. Bihar Renewable Energy Development Agency (BREDA- an agency under Energy Department. Govt. of Bihar) invites application for Registration of Products ranging from (7 Watt to 30 Watt LED luminaries) from the reputed manufacturers for Two (2) years for installation of products under “Mukhyamantri Gramin Solar Street Light Yojana”. However, BREDA reserves the right to extend the registration period as per the requirement.
7. In case there are any Policy declared by GoI/GoB concerned with the current registration process, the same shall be deemed to be a part of this registration process and will be binding on all parties concerned.
8. BREDA reserves the right to carry out the registration process in the entire duration of the project life cycle, as and when required for successful completion of “Mukhyamantri Gramin Solar Street Light Yojana”.
9. BREDA shall carry out the performance review of manufacturers time to time. Following actions will result in debarment/ blacklisting as the case may be and registration of such manufacturer shall be revoked:
 - a) Non-Performance with regard to quality and supply schedule based on objective criteria.
 - b) Submission of fake/ forged test certificates/documents
 - c) Found engaging in corrupt or fraudulent practices.
 - d) Failure of materials supplied.
 - e) Blacklisting by other state, central utilities or other government entities.
10. Blacklisting may be for a period ranging from two to five years.
11. BREDA may reject any (part) or all (full) applications or cancel/withdraw the product registration form without assigning any reason whatsoever and in such case, no applicant/ registered manufacturer shall have any claim arising out of such action.
12. BREDA may seek clarifications/ information/ document/ certificates considered necessary during examination/ evaluation of the applications submitted and the same shall be furnished by the manufacturer within the date and time specified by BREDA.
