## Saansad Adarsh Gram Yojana (SAGY)

D.O. No. M-12016/03/2018-SAGY

Dear sir,

Kindly accept warm wishes for a productive and prosperous new year !!

I am delighted to share that 1,466 Gram Panchayats have been identified under the Saansad Adarsh Gram Yojana (SAGY), across the country till 10 January 2019. So far, 1,176 GPs, through a meticulous structured participatory process have prepared Village Development Plans (VDP) containing 64,072 projects, of which implementation of 51% is already completed.

Would like to reiterate that keeping with the mandate envisaged in the SAGY Guidelines, all projects under SAGY in the GPs identified projects the first three phases by Hon'ble MPs have to be saturated by March 2019. MoRD will be deputing a team of officials and experts from NIRD&PR/SIRDs to all SAGY GPs in the next two months to assess their progress.

In Binar, but of the 81 SAGY GPs, 60 have uploaded VDPs on the SAGY portal, containing 4817 projects. Based on the progress updated by 48 GPs, implementation of 30% projects has been completed till now.

It is requested that necessary instructions may be given to the concerned officials to

(a) expedite the preparation of VDPs in the remaining SAGY GPs. -

- (b) expedite efforts for completing the ongoing projects under SAGY by March 2019. -
- (c) expedite efforts to initiate remaining projects from the VDPs of SAGY GPs.
- (d) update data on the progress of SAGY on the Scheme portal (http://saanjhi.gov.in).
- (e) share progress reports of remaining SAGY GPs in a two-page format, via email to pmu-saanjhi@nic.in. \_ h
- (f) nominate up to five SAGY Gram Panchayats for video documentation.
- (g) share 5 success stories in written form with good quality photographs for documentation.
- (h) Submit the Utilisation certificate against the funds released so far (Details in Annexure)

I am confident that under your able leadership and guidance, we can achieve significant holistic progress in the SAGY GPs.
