Proposals of the agencies not meeting the above criteria shall be summarily rejected.

4. Submission of Bids:

- a) Proposals shall be submitted with technical and financial bids sealed separately. The bidder should put these two sealed envelopes in a bigger envelop duly sealed and submit the same by the specified date and time at the specified place. On receipt, the technical proposals shall be opened first;
- b) The bidder must mention full detail specification of the items quoted. Mere copying of the specifications mentioned by the purchaser or mentioning words like "complying"/"compliable" is not sufficient;
- c) Process flow chart and execution timeline must be enclosed.
- d) Envelope containing bids must bear on the cover itself, name of Tender, name and full address with phone numbers and e-mail id of the bidder.


5. Price Bid

- a) Interlineations, corrections, erasures and/or over-writings shall be valid only if initialed by the person or persons signing the bid.
- b) Applicable Good and Service Tax must be clearly stated. All duties, taxes, freight, insurance, and other levies payable under the contract shall be included in the quoted price.
- c) The rates quoted by the bidder shall be fixed for the duration of the services and shall not be subject to adjustment on any account.
- d) The price quoted will be fixed for one year from the date of signing of contract.
- e) The Prices should be quoted in Indian Rupees only.
- f) Tax will be deducted at source, if applicable.

6. Terms and conditions

- Service to be performed at daily basis, including all week days.
- b) Agency would own the sole responsibility of developing calling content and





obtaining approval from the authority.

- c) Service period: 3 Months (12 weeks) from the date of calling started.
- d) Agency will submit daily report in electronically generated reporting sheet in hard and soft copy both. Report will be in State level Summary, District & PH Division wise Summary and Scheme wise summary. Data of Users called on that would also be shared in excel sheet as per the format approved by the authority.
- e) After the completion of every calendar month, agency will submit a Bill for the payment of services tendered as per the financial bid approved.

Validity of Bid

Offer shall remain valid for a period not less than 160 days after the deadline date specified for submission.

8. Liquidated Damages & Penalties

For delays:

The applicable rate shall be 0.5% per week subject to a maximum of 5 % of the contract price. On further delays contract may be terminated.

For inferior quality services:

Inferior quality of services will not be accepted. In exceptional situation and urgent requirement the goods can be accepted subject to a penalty of 2 to 10%, and on the recommendation of the committee if the goods are acceptable.

In case of any suspicion, quality and certification checks can be done by a committee formed by the authority or can be from third party quality verification agency.

9. Evaluation of Bids

A preliminary evaluation would be undertaken to determine the responsive bids i.e. which

- a) Are properly signed; and
- b) Conform to the qualification criteria and terms and conditions. Bids not meeting the eligibility criteria shall be summarily rejected.

A Evaluation procedure shall be adopted with evaluation of the technical proposal being completed prior to any price proposal being opened and compared.

The financial proposal will be opened only to technically qualified proposals.


10. Award of Contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who in the assessment / judgment and sole discretion of the SPMU-BSWSM, has technical and financial capability to execute the contract.

The authority reserves the right to award the work to one or more of agencies.

- 10.1 Notwithstanding the above, the employer reserves the right to accept or reject any quotations and to cancel the bidding process and reject part/all bids at any time prior to the award of contract.
- 10.2 The bidder whose bid is accepted will be notified of the award of contract by the employer prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.





Performance Security 11.

The successful bidder will be required to furnish the bank Draft of Rs 5,000.00 (Rs. Five thousand only) as performance security.

Any dispute arising out of the Contract, which cannot be amicably settled between the parties, shall be referred to adjudication/arbitration in accordance with Arbitration & Conciliation Act 1996, subject to the following conditions:

In any arbitration proceeding hereunder:

a) Proceedings shall be held in Patna.

b) Hindi or English shall be the official language for all purpose.




