Section 1: Objective of the EoI

The objective of the EoI is to identify and shortlist/ empanel expert (s) and agency (s) who may be asked to provide professional support to start-ups recognized under Bihar start-up policy. These experts may also be asked to provide customized needs based on the requirement of startups. The objective of this document is to provide indicative information about the scope and objective of this activity.

The detailed terms and conditions may be negotiated between startups and the individual as per the scope of requirement by startups.

Section 2: Critical Information

Applicants are advised to study this document carefully before submitting their proposals in response to the Notice. Submission of a proposal in response to this notice shall be deemed to have been done after careful study and examination of this document with full understanding of its terms, conditions and implications.

Section 3: Eligibility Criteria

Bihar Start-up Fund Trust (BSFT) through Department of Industries, Government of Bihar has set up co-working space at B-Hub, Maurya Lok, 5th Floor, Block A, Patna. In this regard, expert individual (s) and agency (s) from various background are required to provide professional support to start-ups.

Professionals and agencies with relevant background are eligible to apply provided they possess the minimum experience as specified below.

3.2 In case of an agency (s), the qualification and experience mentioned above shall be provided either from shareholder or Director or owner or employee working on payroll of the company/ firm/ body.

In addition to above, the agency(s) shall meet the below mentioned criteria.

- a. The agency should be a proprietorship/ partnership firm/ company/ body registered or incorporated in India.
- b. The agency should be operational for at least 3 financial years as of 31st March 2023.
- c. The agency should have an average annual turnover of Rs. 10 Lakhs in last 3 financial years.
- d. As on last date of submission of the Bid, the agency should not be blacklisted by Central Government/ State Governments/ Union Territories/ PSUs in India for unsatisfactory past performance, corrupt, fraudulent or any other unethical business practices.

Section 4: Application Procedure

Interested individual (s) and agency (s) can upload their application along with their CV with a photograph (as per the specified format in Form 1) on the website <https://state.bihar.gov.in/industries>

Supporting Proofs & Documents: Self-attested copy of documents supporting educational qualification certificate, experience certificate, training certificate, address proof etc.

Incomplete application (s) or application (s) without the supporting documents will be rejected & no communication will be made/entertained in this regard.

Section 5: Type of Engagement

The final shortlisted candidates shall remain empaneled for a period of 3 years. The empaneled experts and agencies may be required to work depending on the requirements of the specific engagement.


