This is entered along with other details in the application and related workflow is generated for required processing and report generation.

- 1. User can upload scanned copies of documents which are required for e-registration online.
- 2. The security documents, including bond or bank guarantee, may be sent by courier/ registered post to the registering authority.
- 3. User can upload the required documents from homepage->e-registration->Upload document for -e-registration.
