- 2 Two Passport size Photographs
- Bank Account Details through which transactions are carried out (copy of Passbook / statement of Bank Account showing Bank Name & Bank Account Numbers and other details)
- 4. Copy of PAN CARD of Proprietor/ Partners/ Karta of HUF/advertising agent
- Address proof of location of office / Branch Copy of rent receipt/ lease agreement deed /Municipal Corporation receipt/ Malguzari receipt
- 6. Permanent address proof of Applicant
- 7. Proof of date of commencement of business
