

## **ELIGIBILITY**

### **For Participation in the Tender.**

1. Either MANUFACTURER or their Authorized distributors/Authorized agencies/ Authorized representatives should participate in the tender. In condition of both participating in the tender at a time the participation of the MANUFACTURER will be considered valid and the tender of Authorized distributor/Authorized agencies/ Authorized representatives will be invalid.
  - (i) The Participants should preferably be a MANUFACTURER with strong market standing and having an in-house Research and Development (R&D) facility duly registered with the Department of Science and Industrial Research, Ministry of Science and Technology, Government of India (Relaxable for SSI unit of Bihar or Govt. undertaking /Govt. Enterprises) along with valid registration of the product and appropriate license for manufacturing.
  - (ii) Authorized distributors/authorized agencies & authorized representatives of such manufacturers who are interested to participate have to obtain necessary authorization from their manufacturer along with the copy of manufacturing license & drug license of the manufacturer from whom the veterinary medicines are to be obtained for the supply. In case of imported medicine, the tendered should have valid registration for import of drugs & import license.
2. The bidder must have at least 3 years' experience of manufacturing/marketing of the offered product(s). The bidder shall furnish a Market Standing Certificate from concerned State/Central Drug Control Authority (Chartered Accountant in case of imported drugs and feed-supplements supported by copies of concerning invoices) confirming manufacturing/marketing of the offered product(s), continuously for at least three years prior to date of submission of bid.
3. The bidders must have experience in supply of veterinary medicines to Govt./Semi Govt./Private organizations, bulk purchasers etc. at least for three years as below-
  - (i) **Two or more similar completed works (each costing at least Rs. 50.00 lakhs) aggregating not less than the amount equal to Rs. 300.00 lakhs (supported by invoice) or**
  - (ii) **One Completed Work costing not less than the amount equal to Rs. 350.00 lakhs (Supported by invoice)**
4. For Market Standing, Trade invoice of any two quarters of the quoted product should be from the State of Bihar (limited to five per year) of the last 3 years.
5. The participants should have GST Registration as per GST rules.

6. The firm participating in tender must have not been blacklisted by any Govt. Offices/Govt. undertaking /organizations. In case it is detected later on that the participant firm is a blacklisted one, the Tender submitted by such Bidder would be rejected forthwith and Earnest Money and/or security deposit would be forfeited to the Government in addition to such legal action will be taken as deemed fit and proper. The Bidder should submit an affidavit in this regard.
7. The bidder has to submit necessary drug license for the veterinary medicines.
8. The bidders must have minimum annual turnover of Rs. 10.00 Crore (Ten Crore) for the last three years towards supply of Veterinary Medicines.
9. The bidder must have ISO-Certification 9001-2015/ISI Certification/ GMP Certificate for Veterinary Medicines.

### **For submission of Tender**

There shall be two bid system. (i) Technical-bid and (ii) Financial-bid.

#### **I) Technical Bid**

The bidder has to give the tender form, details regarding the firm (Annexure-II) along with attested photocopies of relevant documents, details regarding the item to be supplied (Annexure-III) along with attested photocopies of relevant documents, check-list (Annexure-IV) and EMD (DD/BG) of requisite denomination in original.

#### **II) Financial Bid**

The bidder should quote the price of veterinary medicines in a separate sheet as per Annexure-V for each veterinary medicine applied for. ***The total price offered for tender must be mentioned at col. no. 09 which must include basic manufacturing price inclusive of transportation cost and any other charges (Excluding applicable tax). The total price mentioned in column no. 09 will be considered for financial evaluation.***

The technical bids are to be opened by the **Technical Committee** of the department on scheduled date and time. The bidders or their authorized representative may remain present at the time of opening of technical bids. At the second stage, financial bids of only the technically accepted offers will be opened for further evaluation and ranking before awarding contract by the **Purchase Committee** on scheduled date and time which will be communicated to the eligible bidders. The bidders or their authorized representative may remain present at the time of opening of financial bids.

## **EARNEST MONEY DEPOSIT (EMD)**

The bidder is required to deposit EMD as required for each veterinary medicine for which the tender is submitted. The above-mentioned amount of EMD should be paid in the form of Bank Draft/ Bank Guarantee of any scheduled bank in favour of "Director, Animal Husbandry, Bihar" payable at Patna and will be placed in cover-1 with technical bid.

The small-scale units located in Bihar shall not be liable to deposit "Earnest Money" in respect of the item covered in their certificate subject to production of attested photocopy of registration certificate. But they will have to deposit "Performance Security" which also be only 20 percent of the General Performance Security amount.

Payment of Earnest Money in any other form (other than as specified above) shall not be accepted in any case. The bidder shall not be entitled to claim any interest on the Earnest Money.

The Earnest Money deposited by unsuccessful bidders will be refunded as early as possible after the tenders are finalized. Earnest Money deposited by the successful bidder will be returned after the deposit of amount towards Security Deposit or may be adjusted towards Security Deposit, if the bidder wants so. Earnest Money deposited with the Director, Animal Husbandry, Bihar, Patna in connection with any other tender even if for same/similar material by the bidder will not be considered against this tender.

The EMD will be forfeited if the bidder withdraws the tender or does not accept the approved list or does not supply the items within the stipulated time as per the terms & conditions of tender or the product supplied is proved to be of substandard quality.

## **RIGHT OF ACCEPTANCE/REJECTION OF TENDER**

The following documents must be submitted by the bidder along with tender papers.

1. EMD (Earnest Money Deposit) or necessary document from concerned authority towards exemption of EMD.
2. Attested Photocopy of the up-to-date manufacturing license of the manufacturer. In case of quoted items from overseas manufacturer/ MNC, an undertaking for submission of the manufacturing license before award of purchase order.
3. Attested photocopy of in-house Research and Development (R&D) facility duly registered with the Department of Science and Industrial Research, Ministry of Science and Technology, Government of India.

4. Attested photocopy of Market Standing Certificate from concerned State/Central Drug Control Authority (Chartered Accountant in case of imported drugs and feed-supplements supported by copies of concerning invoices) confirming manufacturing/marketing of the offered product(s).
5. **For Market Standing, Attested photocopy of Trade invoice of any two quarters of the quoted product should be from the State of Bihar (limited to five per year) of the last 3 years**
6. Attested photocopy of the valid Drug license for the items from competent authority.
7. Attested Photo copy of PAN card.
8. Income Tax return for the last three Assessment Years.
9. Attested Photocopy of up to date valid GST clearance certificate.
10. Attested photocopy of GST Registration Certificate.
11. Detail Name, Address, telephone No., Fax, E-mail, of the firm & of the Director/Managing Partner/Proprietor/Authorized person of the firm must be mentioned in the tender form.
12. Attested Photocopy of i) Original Authorization Certificate ii) Manufacturing license iii) Drug license from the manufacturer for supply of veterinary medicines in case of authorized representatives/ authorized distributor / authorized agency.
13. Attested photocopy of Annual Turn Over (Minimum Rs. 10.00 crore) disclosed in GST Returns of last three years or Certificate issued by Chartered Accountant to this effect for last three years.
14. Affidavit regarding not blacklisted as well as not facing any enquiry by any Govt. Offices/Govt. undertakings /organizations.
15. Experience certificate (along with copies of GST bills) of supplying the items of veterinary medicines for not less than 3 years to Government/semi-government/Private Organizations, bulk purchasers etc.
16. Annexure "II", "III", "IV" and "V" should be duly filled.

All Documents should be attested by the bidder or their authorized representative.

**No tender shall be considered if the same is not supported with the above documents mentioned at Sl. No.1 to 16.**



The right of acceptance of tender and award of contract rests with the **Purchase Committee**, which does not bind itself to accept the lowest tender and also reserves the right to reject any or all the tender(s) received without assigning any reason whatsoever.

Any dispute arising in the future will be finalized by the Principal Secretary/Secretary, Department of Animal and Fisheries Resources, Bihar. The legal dispute is subject to the competent court of justice at Patna only.

### **SECURITY DEPOSIT**

1. The successful bidder(s) shall have to furnish the performance security deposit (PSD) @ 5% of the value of estimated annual requirement (as inscribed in tender document) of a particular drug in the form of DD/BG of any scheduled bank in favour of **Director, Animal Husbandry, Bihar, Patna** & payable at **Patna** only. The EMD deposited by successful bidder may be adjusted towards Security Deposit if the bidder wants so.
2. The performance security deposit shall be forfeited if successful bidder fails to supply the goods in stipulated time or fails to comply with any of the terms & conditions of the tender/supply order/agreement or fails to sign the agreement.
3. The small-scale units located in Bihar will have to deposit only 20 percent of the general security amount. However, after receiving the purchase order, if they fail to supply the goods, without any appropriate reason, they will be blacklisted as per the procedure laid down.
4. In the event of failure of payment of Security Deposit, the order is to be treated as cancelled and steps will be taken to place the indent to next approved firm of the tender after due negotiation and after approval from the Govt. The successful bidder shall not be entitled to claim any interest money on the amount of Security Deposit.
5. The Security Deposit will be released & returned back to the bidder after successful supply of the ordered goods. The Security Deposit shall be forfeited in case the item of supply is found to be of sub-standard quality by the competent authority.

### **VALIDITY OF TENDERS**

1. All the tenders shall remain valid for acceptance for the financial year 2022-23 and 2023-24 or till finalization of the next tender whichever is earlier. If adoption of next approved list is delayed beyond the financial year 2023-24, the terms, conditions and the approved price of the items in the approved list may be extended for a period as desired by the Director, Animal Husbandry, Bihar.


2. No extension of time shall be allowed for submission of tender under any circumstances unless otherwise specifically extended by the Director, Animal Husbandry, Bihar.

**BIDDER'S UNDERSTANDING OF THE TENDER DOCUMENT**

The bidder shall carefully go through the tender documents and fully inform himself to all the terms and conditions contained therein before submission of the tender. If the bidder finds discrepancies or omission or be in doubt as to their meaning relating to tender documents, he should at once inform the Director and obtain clarification in writing prior to submission of this tender. Verbal clarification or information given by the Director, Animal Husbandry, Bihar or the employees working under him or his representatives shall not be binding on the Director.

**NO CLAIM OF COMPENSATION FOR SUBMISSION OF TENDER**

No Bidder shall be entitled to claim any cost, charges, expenses etc. incurred by him or incidental therein connection with submission of this tender even though the Department may elect to withdraw the invitation of Tender, without notice and without assigning any reason whatsoever.

**TERMS AND CONDITIONS**  
**FOR SUBMISSION OF TENDER FOR**  
**SUPPLY OF VETERINARY MEDICINES FOR THE YEAR**  
**2022-23 and 2023-24**

The bidder should carefully read all the terms & conditions before preparing the tender documents for participation in the tender.

**A. Instructions to bidders while downloading the tender document.**

Each set of Tender documents shall be serially page marked. The Bidder should check the documents immediately after downloading of the same. If there are any lapses, the Bidder should immediately report the fact to the Director for its rectification, if any.

**B. Instructions to bidders while submitting the Tender Papers.**

1. All the tender documents along with the enclosures should be signed at the bottom by the bidder in each page (Serially page marked with indexing) with date.
2. Capital letters should be used in filling up of the tender form and should be neatly typed/computerized.
3. All corrections, additions, alterations in the tender documents shall be authenticated by initial/ signature of the bidder.
4. Rates should be quoted on the prescribed tender form (Annexure V). The rates offered should be written both in figures and in words and no erasing, cutting or overwriting shall be entertained.
5. All information in these tender documents shall be in English only.
6. Bidder, if desires may cite the Brand name in addition but not as a replacement of generic name.
7. Bidder firm should not quote any item which they have no endorsement in their MANUFACTURING LICENSE. In case of quoted items from overseas manufacturers/MNCs, it is required to submit an undertaking to furnish the manufacturing license before awarding of purchase order, if selected.
8. The rate to be quoted by the bidder should be **F.O.R. destination at the offices of District Animal Husbandry Officers under the department inclusive of transportation charges and any other charges (Excluding applicable tax).** The rate should be quoted in **Indian currency** only. It is necessary that specific brand, make etc. should be clearly mentioned on the tender paper furnished to compare the composition and the rate against multiple offers.
9. The bidders must quote the rate of the items for which they have been specifically asked for as per tender schedule. Bidders quoting the rates different from those mentioned in the tender schedule may be liable to rejection. Tender

containing clerical error/typographical error/arithmetical mistake (s) may be liable to rejection.

10. Bidders who are manufacturers of the veterinary medicine to be supplied by them must furnish attested copy of the certificate from the appropriate licensing authority along with the tender documents confirming that they are actually manufacturing these veterinary medicines.
11. The bidders shall quote the tender price at Col.-09 of Annexure-V, which shall be inclusive of transportation charges and any other charges (Excluding applicable Tax). The GST should be charged as per the Government guidelines.
12. The Bidder is required to submit detail brochures & leaflets in respect of the items of veterinary medicine offered in the Tender along with the Technical bid and produce **at least two strips/vials of the sample** for scrutiny by the **Technical Committee**, failing to which, the items so offered will not be considered. The samples of the successful bidders received shall be kept as "Master Sample" for verification against the supplied items.
13. The price preference for S.S.I. units located inside the state of Bihar will be given in accordance with the Government industrial Policy/Resolution in vogue. The Bidders who are S.S.I. units should submit relevant documents from the competent authority along with the tender documents stating the Permanent Registration number and Date and the names of the items for which registered. The words **S.S.I. unit located inside the state of Bihar** should be marked in **Red Ink on the right-hand top corner of the Tender documents**.
14. The Tender filled by the proprietorship concerns should be signed by the Sole Proprietor

or

by the Managing Partner in case of Partnership firm.

or

by Managing Director or any Member of Board of Directors along with the authorization by means of resolution of Board of Director in case of company

or

by a person having valid power of attorney on behalf of competent authority in respect to file tenders and to execute all requisite deeds.

In case of Partnership firm, the copy of partnership deed duly attested by Gazetted Officer to be submitted.

Copy of the Certificate of incorporation should be furnished in support of the firm being registered under the companies Act.

15. Submission of more than one Tender by a particular Bidder under different names is strictly prohibited. In case it is found later on that this condition has

been violated, all the tenders submitted by such Bidder would be rejected or cancelled and Earnest Money and/or Security Deposit forfeited to Government in addition to such legal action will be taken as deemed fit and proper.

16. Tenders directly received from the manufacturers will be given preference subject to they have branches/sales depot in the State of Bihar. Tenders of any firm newly constituted, inexperienced and without credibility will be rejected. The Manufacturers or their Authorized distributors/ Authorized agencies/ Authorized representatives having valid registration should have minimum three years' experience in supplying Veterinary medicine to Govt./Semi government/ Private organizations, bulk purchasers etc. as below -

- i. **Two or more similar completed works (each costing at least Rs. 50.00 lakhs) aggregating not less than the amount equal to Rs. 300.00 lakhs (supported by invoice) or**
- ii. **One completed work costing not less than the amount equal to Rs. 350.00 lakhs (supported by invoice).**

**Besides, they should have to submit a Market Standing Certificate from concerned State/Central Drug Control Authority (Chartered Accountant in case of imported drugs and feed-supplements supported by copies of concerning invoices) confirming manufacturing/marketing of the offered product(s), continuously for at least three years prior to date of submission of bid along with proof of annual turnover of minimum Rs. 10.00 Crore in supply of veterinary medicine for preceding 3 years in support of establishing the soundness of the firm and its business credibility towards competition in the tender.** For Market Standing, Trade invoice of any two quarters of the quoted product should be from the State of Bihar (limited to five per year) of the last 3 years and it should be legible as it is to be considered as an essential document for technical evaluation. Bid without such invoice will lead towards rejection of the tender.

  - ii) The financial bid comprising Annexure-V only is to be submitted in another sealed envelope, the top of the cover must be super-scribed with "**Financial bid for supply of Veterinary Medicine - 2022-23 and 2023-24**" and name and address of the bidder on left side of the envelope.
  - iii) Both the **technical bid** and the **financial bid** should be sealed by the bidder in separate envelope as mentioned above and both these sealed covers are to be put in a bigger envelop which should also be sealed and duly super-scribed "**Tender for supply of Veterinary Medicine- 2022-23 and 2023-24**" on the top of the envelop to be addressed to **The Director, Animal Husbandry, Bihar, New Secretariat, Vikas Bhawan, Patna-800015** and name & address of the bidder should be mentioned on left side of bigger envelope.
  - iv) The Tenders in sealed cover should be inserted in the **Tender Box** in the office of the **Director, Animal Husbandry, Bihar** as per time schedule already mentioned in the tender document. If the due date so mentioned above is declared as a holiday by the Govt. of Bihar, the last date and time for submission and opening of tenders shall respectively be the time as aforesaid on next working day.

19. Submission of Tender by any other means will not be accepted.

If adoption of next approved list is delayed beyond financial year 2023-24, the terms, conditions and the approved price of the items in the approved list may be extended for the period taking approval from the Director, Animal Husbandry, Bihar.

21. **THE DEPARTMENT PURCHASE COMMITTEE/BIDDER AUTHORITY/UNDERSIGNED RESERVE THE RIGHT:**
- a. To reject any/or all the Tenders at any stage without assigning any reason there of and not to accept the lowest Tender.
  - b. To invite fresh offers from the open market or negotiate with other bidders quoting higher rate to come down to the lowest rate of the item offered by the competitors in the tenders.
  - c. To purchase **Veterinary Medicines** at the approved rate of the catalogue from any outsider during the Tender/Contract Period in case of emergency, if the Bidders fail to supply such items on short notice or stops supplying on any other matter.
  - d. To withdraw the item from the tender at any stage. In such contingency the selection of such item already made in favour of any bidder shall be treated as cancelled.
  - e. Not to give price preference to Bidders in compliance with the existing orders issued by this State Government at the discretion of the Purchase Committee.
  - f. To procure the item of the tender directly from State/Central Govt. Undertaking firms even if a tender of other parties for the same item has been offered/ accepted/approved.
  - g. To make additions to or deletion from the list of consuming units/delivery points to any time during the period of validity of the tender or of the contract in pursuance of the Tender.
  - h. To process the tender groups separately.
22. Approval of items of successful bidders will be notified/ issued by the authority in due course.
23. The successful bidder(s) has to execute an **Agreement** on Indian non judicial stamp paper of appropriate denomination (as stipulated by the State Govt. of Bihar) at Directorate Level. He/They is/are also required to furnish the performance security deposit (PSD) @ 5% of the value of estimated annual requirement (as inscripted in tender document) of a particular drug in the form of DD/BG of any scheduled bank in favour of **Director, Animal Husbandry, Bihar, Patna & payable at Patna only.**
24. The specification and quantity of the item needed as mentioned in the tender notice is tentative and is subject to increase/decrease as per requirement and availability of fund. The payment would be made for actual supply taken and no claim in this regard should be entertained otherwise.

25. The **Supply Order** to the successful bidder will be given by the concerned District Animal Husbandry Officer. In case the successful bidder (L<sub>1</sub>) is unable to supply the item(s) in requisite quantity within 15 days of the supply order or within stipulated time as mentioned in the supply order, for smooth and uninterrupted supply, the supply order may be distributed to more than one party on approved rate. The successful bidder will have to supply the item(s) to the offices of the District Animal Husbandry Officers under the department in accordance with the conditions mentioned in the Tender Notice, Agreement and Supply Order. Physical verification of the supplied item(s) will be done by an officer authorized by concerned Regional Director, Animal Husbandry for this purpose. Copy of quality test report of the veterinary medicines being supplied must be submitted to the concerned District Animal Husbandry Officers along with supply.
26. Payment against all the accepted supplies will be made by the concerned District Animal Husbandry Officer. No payment will be made before completion of supply.
27. The period of firmness of the approved rates is financial year 2022-23 and 2023-24. However, if at any time during the period of contract, the price of any tendered item is reduced or brought down by any law or act of the Central or State Government or the bidder, the bidder shall be morally and statutorily bound to inform the Director, Animal Husbandry, Bihar immediately about such reduction in the contract price. The Director, Animal Husbandry, Bihar is empowered to unilaterally effect such reduction as is necessary in rate, in case the bidder fails to notify or fails to agree for such reduction of rate.
28. If the performance of the approved firm is found to be not satisfactory for irregular supply of approved items against indents placed during the validity period of the tender, the Earnest/Security Money deposited by the approved firm will not be released and the Security Money shall be decided by the competent authority to be forfeited. The tender of the firm will not be entertained in future.
29. The Earnest Money Deposit furnished by the Bidder will liable to be forfeited, if the Bidder withdraws his tender as a whole or for any particular item at any stage after the submission of the tender or fails/refuses to enter into written agreement for any/or all other items of his accepted tender within the time specified when requested to do so or refuses to deposit Security Deposit. The deviation if any in this regard must be reported before Purchase Committee and Director.
31. All the supplies should invariably display the particulars on its label and/or carton in a distinct manner.
32. Abnormally low price of an item quoted by the bidder in the Tender with some *malafide* intention will not be accepted, if detected and his offer will be rejected.
33. Bidders shall not be permitted to alter or modify their bids after expiry of the dateline for receipt of bids.
34. In exceptional cases where the price negotiation is necessary due to some unavoidable circumstances, the same may be resorted to only with the lowest evaluated responsive bidder.
35. If any situation arises, where the lowest evaluated responsive bidder is not in a position to supply the full quantity required, the remaining quantity, as far as possible, be ordered on the next higher responsive bidder(s) at the rate offered by the lowest evaluated responsive bidder, on the specific recommendation of the Purchase Committee. Further, in case of emergency need when inconvenience to the public service is caused for delay in the process of procurement, the concerned District Animal Husbandry Officer may go for purchase strictly as per provision of Bihar Financial Rules.


