



1. Introduction

The objective of this document is to solicit proposals from Service Provider (SP) for Digitization of Animal Records of Govt. of Bihar in Information Network For Animal Productivity And Health (INAPH) software as per the scope of work defined in this RFP. This document spells out the bidding terms, bid evaluation process, payment schedule, delivery schedule, scope of work, Service Level etc.

2. Basic Information

2.1 BLDA invites responses ("Tenders") to this Request for Proposals ("RFP") from Service Providers for Digitization of Animal Records of Govt. of Bihar as described in this RFP. The detailed Scope of work is elaborated in this RFP. Subcontracting of any part of the Scope of Work or the entire Scope of Work is strictly prohibited.

- a) Proposals must be received not later than time, date and venue mentioned in the Tender Notification Table. Proposals that are received late will not be considered in this procurement process.
- b) BLDA will award the Contract to the successful bidder whose proposal has been determined as the best value proposal based on Technical and Financial evaluation criteria and accepted by the Tender Accepting Authority.

3. Scope of Work

The entire Scope of Work involves data digitization of animal records of GoB. The Service Provider(SP) shall carry out the following activities as part of data digitization.

3.1. Digitization of tentative 2,31,17,774 animal data after Ear tagging, located at all 38 District level of Bihar state for registration using the INAPH software for Data Entry and Digitization to be supplied by District Animal husbandry Officer Office.

3.2. The Service Provider shall bring all the requisite equipment (PCs / Laptop/UPS/Anti-Virus,etc), High speed internet, infrastructure and manpower(Data Entry Operator/Supervisor) for this work at district level and shall take them back once the activity is complete.

3.3 The Service Provider should ensure 100% clarity and accuracy in documents being digitized. The Digitized Document should be error free.

3.4 Entry of Data from filled-in-schedule software for the State of Bihar pertaining to a project under the Govt. of India. Numbers and words will have to be entered in English. The Schedule forms will be in Hindi /English. The data entry screen of schedules is given in the **Annexure: IX**.

3.5 Generation of error (check) list with summary and handing over the same to the local representative of District Animal Husbandry Officer (D.A.H.O.).

3.6 To collect corrections advices provided by the Department Officials from the representative of concerned district D.A.H.O. and incorporate the corrections in the relevant data file.

3.7 To continue the process till the data is completely error free as certified by concerned district D.A.H.O.

3.8 The Agency shall be responsible for entry of the Documents at their own cost which are received by staff & officials of DAHO/representative of DAHO and the documents would have to be returned at the same office after completion of work at their own cost.

5. Objective of this RFP Document

The Request for Proposal (RFP) document is purely for the selection of Agency for "RFP for online/offline data entry services for Animal Husbandry department.

6. Instructions

- i. Tenders should be fully in accordance with the requirements of the specified in this RFP.
- ii. All offers should be made in English. Conditional offers and offers qualified by such vague and indefinite expression such as "Subject to immediate acceptance", "Subject to prior sale" etc. will not be considered.
- iii. The Price and conditions of the offer should be valid for at least a period of 120 days from the Date of tender opening. Quotations/Bids with validity of less than 120 days may be rejected.
- iv. Submitted Tender forms, with overwritten or erased or illegible rate or rates not shown in figures and words in English, will be liable for rejection. In case of discrepancy between words and

figures noted against each items of the tender and between unit rates and the total amount, the decision of the tender issuing authority " The Project Director, Bihar Livestock Development Agency, Patna" will be final and binding on the bidders.

- v. The bidder shall make its own arrangements, for "RFP for online/offline data entry services for animal husbandry department.
- vi. While tenders are under consideration, bidders and their representatives or other interested parties, are advised to refrain from contacting by any means Purchaser's personnel or representatives, on matters relating to the tenders under study. The Project Director, Bihar Livestock Development Agency, Patna, if necessary will obtain clarification on tenders by requesting such information from any or all the bidders either in writing or through personal contact as may be necessary. The bidder will not be permitted to change the substance of his offer after the tenders have been received in " The Project Director, Bihar Livestock Development Agency, Patna". Any attempt by any bidder to bring pressure of any kind, may disqualify the bidder for the present tender and the bidder may be liable to be debarred from bidding for Bihar Livestock Development Agency, Patna.
- vii. "Agreement" means the Agreement to be signed between the successful bidder and "The Project Director, Bihar Livestock Development Agency, Patna " including all attachments, appendices, all documents incorporated by reference thereto together with any subsequent modifications, the RFP, the bid offer, the acceptance and all related correspondences, clarifications, presentations.
- viii. "LOI" means issuing of Letter of Intent which shall constitute the intention of the Tendered to place the Purchase Order with the successful bidder.
- ix. "Proposal" means Pre-qualification cum Technical Proposal and Financial Proposal.
- x. "Request for Proposal (RFP)", means the detailed notification seeking a set of solution(s), services{s), materials and/or any combination of them.
- xi. "Service" means provision of Contracted service viz., operation, maintenance and associated services for the NIT as per this RFP.
- xii. "Termination Notice" means the written notice of termination of Agreement issued by one Party to the other in terms hereof.
- xiii. SLA: Service Level agreement between Bihar Livestock Development Agency, Patna and the Vendor of the project.
- xiv. For all the parts/controller cards/devices, the make and model should be mentioned in the Pre-qualification cum technical bid with complete details.
- xv. All disputes are subject to jurisdiction of Patna High Court only.

7. General Terms and Conditions

Note: Bidders should read these conditions carefully and comply strictly while submitting their tenders.

I. Items under the contract:

The detailed Technical Specifications of the Systems proposed are given in the Technical Bid Section.

II. Opening and Validity of the Bids:

The bids will be opened on scheduled date and time even in case of absence of the bidders. Financial bid should be valid for a minimum period of 120 days from the date of tender opening for placing the initial order.

III. Period of contract:

The work against the tender is for 06 months requirement & the terms & conditions of this tender shall be operative for a period of 06 months from the date of signing of agreement between the Office & the contractor. The period can be extended by another 3 months or till the new tender is finalized, whichever is earlier with the same terms and conditions with satisfactory work on mutual consent

IV. Responsibilities of Vendors:

The vendor will be responsible for service support during the contract period and the same shall be discharged through own service engineer/Authorized Service Engineer of the vendor.

V. Bihar Livestock Development Agency ,Patna reserves the right to reject any or all the tenders without assigning any reason whatsoever. Bihar Livestock Development Agency ,Patna would not be under obligation to give any clarification to such rejected tenders. Bihar Livestock Development Agency, Patna may decide not to procure any particular item even after opening the bids.

8. Local Conditions

- a. Each Bidder is expected to fully get acquainted with the local conditions and factors, which would have any effect on the performance of the contract and /or the cost.
- b. The Bidder is expected to know all conditions and factors, which may have any effect on the execution of the contract after issue of letter of Award as described in the bidding documents. The Tendered shall not entertain any request for clarification from the Bidder regarding such local conditions.
- c. It is the Bidder's responsibility that such factors have properly been investigated and considered while submitting the bid proposals and no claim whatsoever including those for financial adjustment to the contract awarded under the bidding documents will be entertained by the Tendered. Neither any change in the time schedule of the contract nor any financial adjustments arising thereof shall be permitted by the Tender on account of failure of the Bidder to know the local laws / conditions.

9. Eligibility Criteria (Pre-Qualification cum Technical)

Bidder has to submit proof in pre-qualification criteria for following conditions:

- The bidder should be a Agencies/ Contractors / Company / Firm /

System Integrator / IT Company for participation in this Tender but not consortium.

- The bidder should be registered in Bihar Shop & Establishment act 1953 and Small Scale Industry, Bihar from 3 (three) Years.
- The bidder must have experience of completed project minimum 25 Lakh online/offline data entry of Information Technology in Bihar for last 3 (three) years.
- The bidder should have minimum average annual turnover of INR 03 Crore or above in the last three financial years. The bidder should have to submit audited Balance Sheet and P & L account for last three financial year (2016-17, 2017-18, 2018-19 or 2017-18, 2018-19, 2019-20) with auditor's report.
- The Net-worth of the bidder should be positive and should be minimum 1 Crore in last financial year 2018-19 or 2019-20.
- The bidder have to provide GST number with GST submission of minimum INR 10 (Ten Lacks) in financial year 2019-20.
- The bidder should be registered in EPF& ESIC, Bihar from minimum 3 (three) years.
- The Bidder shall provide self declaration certification for non-engagement in fraudulent corrupt practices, non blacklisting in any Govt'/PSU/Bank in last three financial year (**Annexure-VII**).
- The bidder should have experience for Population census, Agriculture Census, Livestock census, NPR Digitization, Banks, PSU, Election Commission of India, BPL & Manrega Data Entry work, to provided work order/experience certificate attached.
- The Bidder should be ISO Certified Firm (ISO 9001:2008/9001:2015 or any latest standard).
- The bidder have to provide Non-Refundable tender cost of Rs.1,000/- in the form of Demand Draft issued by a nationalized bank, drawn in favour of " The Project Director, Bihar Livestock Development Agency, Patna" payable at Patna attached with technical BID.
- The bidder have to provide Earnest Money Deposit (EMD) @ 5% of total quoted/offered amount by bidder in the form of Demand Draft issued by a nationalized bank, drawn in favour of " The Project Director, Bihar Livestock Development Agency, Patna" payable at Patna.

12. Language of Bid

The Bid prepared by the Bidder and all correspondence and documents relating to the Bid exchanged by the Bidder and the BLDA, Patna shall be written in English language only.

13. Amendment of Bid Documents

At any time prior to the deadline for submission of Bids, the BLDA, Patna may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the Bid Documents through amendment/so Such amendment/s will be binding to bidders.

14. Bid Extension,if any

BLDA, Patna may extend the deadline for the submission of Bids, in order to allow prospective Bidders a reasonable time in which to take the amendment into account in preparing their Bid.

15. Appointment of the Committee

- 1. The Committee of the BLDA, Patna will evaluate the Bids.
- 2. BLDA, Patna decision would be binding on the Bidder.

16. Pre-Qualification cum Technical Bid: Evaluation

The evaluation of the Technical bids will be carried out in the following manner: The bidders' technical solution proposed in the bid document is evaluated as per the requirements specified in the RFP and adopting the evaluation criteria spelt out in this RFP. The Bidders are required to submit all required documentation in support of the evaluation criteria specified (e.g. detailed project citations and completion certificates, client contact information for verification, profiles of project resources and all others) as required for technical evaluation. The committee may seek clarifications from the bidders. The primary function of clarifications in the evaluation process is to clarify ambiguities and uncertainties arising out of the evaluation of the bid documents.

(A) Evaluation of Technical Bids:

A detailed evaluation of the technical bids shall be carried out in order to determine whether the technical aspects are substantially responsive to the requirements set forth in the RFP/Tender Enquiry. This may include physical verification for assessing the capacity of the bidder.

- I. The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. whether bids;
 - a. are properly signed;
 - b. meet the eligibility requirements specified;
 - c. Aligned to the terms and conditions, and specifications; and

- d. Consequent upon the evaluation, each Technical bid will be assigned a Technical Score of a maximum of 100 points. The Bidders minimum criteria & scoring 60 marks or above and whose Techno- commercial Bid is substantially responsive to the requirements of the Tender Documents shall only be considered qualified. However, in case of number of technically qualified bidder is less than three, the cut-off marks may be reduced to accommodate top three bidders, but in any case it should not be below 50 marks. The Financial Bid of such qualified Bidders shall only be opened.
- II. The Department reserves the right to ask for a technical elaboration/clarification the form of a technical presentation from the Bidder on the already submitted Technical Proposal at any point of time before opening of the Financial Proposal.
- III. No further discussion/Interface will be held with the bidder whose bid has been technically disqualified / rejected.

(B) Technical evaluation methodology:

- a) The technical scores of the bidders will be announced prior to the opening of the financial bids.
- b) The technically short listed bidders will be informed of the date and venue of the opening of the Financial bids through an oral/ written (e mail) communication.

(C) Evaluation of Financial Bids:

The Financial Bids of only the technically qualified bidders will be opened for evaluation. The bidder with lowest Total Financial Quote (Lt) shall be selected as successful bidder.

If the Financial proposals are same for one or more Firms then firm getting higher score/ marks will be declared successful.

17. Non Transferable RFP

The RFP document is not transferable. Only the party who has purchased this RFP shall be entitled to submit their bid.

18. Completeness of RFPOffer

The Bidder is expected to examine all instructions, forms, terms, conditions and specification in this RFP Document. Failure to furnish all information required by the RFP documents or submission of a offer not substantially responsive in every respect to these RFP documents \NIII result in rejection of the bid. This offer Is liable to be rejected without any intimation to the Bidder, If complete information is not given therein, or if particulars asked in the Forms/ Performa in this RFPare not fully furnished.

19. Submission of Proposal

- a) All the proposals will have to be submitted in hard bound form with all pages numbered, seal & signed. It should also have an index giving page wise information of document; incomplete proposal will summarily be rejected.
- b) No bid will be considered unless and until each page of the bid document is duly signed by the authorized signatory.
- c) Pricing information should not be shared in the Technical Bid.
- d) EMD enclosed with technical BID.
- e) The proposals shall be submitted in two parts, viz.,
- f) **Envelope 1:-** Technical Proposal super scribed as "Envelope 1 -Technical Proposal", complete with all technical details. In the technical proposal, there should not be any indication about the prices of any of the products offered.
- g) **Envelope 2:-** Financial Proposal containing Price Schedule super scribed as "Envelope 2 - Financial Proposal".
- h) The two sealed envelopes should again be placed in a single sealed envelope, to be submitted **at the office of Project Director, Bihar Livestock Development Agency, P.O. Bihar Veterinary College campus, Patna-800014** up to the due date and time mentioned in the schedule above in the document.

20. Late Bids

Any bid received after the time and date for receipt of bids prescribed in this document will be rejected and returned unopened to the Bidder.

21. EARNEST MONEY DEPOSIT (EMD)

- (i) All bids submitted in response to this RFP document shall be accompanied by Earnest Money Deposit (EMD) Rs. 11,55,890/- (Eleven Lakh Fifty Five Thousand Eight Hundred Ninty only), In the form of a Demand Draft in favor of "**Project Director, Bihar Livestock Development Agency**" Payable at SBI Bihar veterinary collage campus, Patna-14. It should be attached with technical BID.
- (ii) **Forfeiture of Earnest Money Deposit (EMD):-** The EMD submitted along with the bid shall be forfeited under the following conditions:
 - a) If the bid is withdrawn during the validity period or any extension agreed to by the Bidder thereof.
 - b) If the bid is varied or modified in a manner not acceptable to the Purchaser after opening of Bid during the validity period or any extension thereof.
 - c) If the Bidder tries to influence the evaluation process.
 - d) If the Bidder withdraws his Bid during evaluation.
 - e) If the Bidder does not accept the correction of errors in his bid.
 - f) If the Bidder is successful and fails to sign the Contract within the time stipulated by the Purchaser.
 - g) If the Bidder refuses to take up the job within the time stipulated by the purchaser.

(iii) **Refund of EMD:-** The EMD will be refunded as follows:

- a) In the case of unsuccessful bidders, the EMD will be returned to them without any interest accrued thereon at the earliest after the final bid validity period and latest on or before the 30th day after the award of the contract to the successful bidder.
- b) In the case of selected bidder (s), the EMD shall be refunded after closure of contract.
- c) The Earnest Money Deposit of the successful bidder will be converted as performance guarantee.

22. OTHER TERMS AND CONDITIONS

The tender should be submitted in two bid sealed in a big envelope and clearly marked on them the RFP No., Type of Bid and Due Date. The tender should reach the office of Project Director, Bihar Livestock Development Agency, P.O. Bihar Veterinary College campus, Patna-800014 by Registered / Speed Post/ Representative of the bidders only on or before due date and time. The tenders received after due date or time shall not be considered.

- The technical bid will be opened on 28.07.2020 At 15:00Hrs by the authorized committee.
- Incomplete/conditional/telegraphically/fax/e-mail tenders will not be considered.
- Inspection agency- the respective district level office and state level office.
- Bidder should sign all the pages of tender/schedule of tender, if any
- The Bidder is at liberty to present himself & the tune of opening of the tender or may detail the authorized representative on the date and time specified in the schedule. The name and address of the representative who would be attending the opening of the tender should be indicated in the tender form **(Annexure-IV)**.
- The rate should be quoted in the format enclosed with this tender form only **(Annexure-V)**.
- BLDA will not responsible for any postal delay or any other reason beyond his control.
- In case of any dispute whatsoever, decision of Project Director, BLDA shall be final. For any legal dispute, the territorial jurisdiction will be Jurisdiction of High Court of Patna only.
- Financial bid will be opened only after approval of technical bid.
- Undertaking on no conflict of Interest **(Annexure-III)**.

23. ACKNOWLEDGEMENT Copy

Signing and returning the acknowledgment copy of a contract issued by or beginning work under that contract shall constitute acceptance of a binding agreement between Bihar Livestock Development Agency and the successful

bidder.

24. PAYMENT TERMS

Data Entry/Digitization-

- 24.1 To avoid delay of payment, all bills should contain the copy of Work order. No advance payment would be entertained.
- 24.2 Payment will be made phase wise within 45 days from the date of submission of bills clear in all respects.
- 24.3 The Office will accept part-Bills for the part of jobs completed. The Bill has to be accompanied by a certificate of acceptability of the work by the District Nodal officer/ District Animal Husbandry Officer/ Authorized officer of District Level.
- 24.4 If the actual quantum of work turns out to be lesser or more than estimated one, or if there is any change with respect to taxes and duties, the rates quoted shall remain unchanged. The rate per schedule is to be quoted in **Annexure-V** (excludes GST).

25 MODIFICATION AND WITHDRAWAL OF BIDS:

The bidder may modify or withdraw his bid after submission, provided that the intimation is deposited by the bidder in a properly sealed envelope in the office, before the scheduled time & date for closing of tender. No bid shall be modified subsequent to the deadline for submission of bids.
