The bid received after due date and time will not be entertained whatsoever may be the reason. The technical bids shall be opened on the same day at **04:00 PM** in the office of **The Director, Animal Husbandry, Bihar**. In the event of the above mentioned date being declared as a holiday/closed day, the tenders will be received and opened on the very next working day at the scheduled / appointed time. The date of opening of financial bid of technically qualified agencies will be announced later.

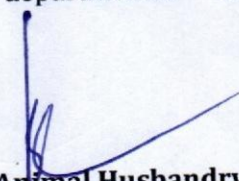

ELIGIBILITY

(A)- For Participation in the Tender -

1. The Authorised Agencies/ Authorised Representatives / Company/ Firm/ Trust/ Society/ Authorised Distributor/ Pig Farm Owners & authorized representatives who are interested to participate will have to obtain necessary authorization from the concerned Pig Farm Owner for supply.
2. Participant in the tender must be registered under GST rules.
3. The bidder must have not been blacklisted as well as not facing any enquiry by any Govt. Offices/ Govt. undertakings/ organizations. In case it is detected later on that the participant firm (bidder) is a blacklisted one or facing any enquiry, the Tender submitted by such Bidder would be rejected forthwith and Earnest Money and/or security deposit would be forfeited to Government in addition to such legal action will be taken as deemed fit and proper. The Bidder should submit a fresh affidavit in this regard.
4. The bidder must have experience in supply of any of the breeds as mentioned in specification to Govt./Semi Govt./Private organizations, bulk purchasers etc. at least for last one year.
5. The bidder must have minimum average annual turnover of Rs. 20.00 Lakh (Twenty Lakh) last one year towards supply of (breeds as mentioned in specification) .
6. The Tender Document should be serially mared with Index.

(B)-For submission of tender -

There shall be two bid system - (i) **Technical-bid** and (ii) **Financial-bid**.

i) Technical Bid

The bidder has to give the tender form, details regarding the

Breed, Bidder (Annexure-II) along with attested photocopies of relevant documents, details regarding the item to be supplied (Annexure-III) along with attested photocopies of relevant documents, check-list (Annexure-IV) and EMD (DD/BG) of requisite denomination in original.

II) Financial Bid

The bidder should quote the price of one unit as per specification, for the item applied for. Bidder May quote rate for one or more district. The total price offered for tender must be mentioned at col. no. 8. The total price offered must include all cost price inclusive of all applicable taxes and any other charges including F.O.R transportation cost.

The technical bids are to be opened by the Technical Committee of the department on scheduled date and time. The bidders or their authorized representative may remain present at the time of opening of technical bids. At the second stage, financial bids of only the technically accepted offers will be opened for further evaluation and ranking before awarding contract by the **Purchase Committee** on scheduled date and time which will be communicated to the eligible bidders. The bidders or their authorized representative may remain present at the time of opening of financial bids.

EARNEST MONEY DEPOSIT (EMD)

The bidder is required to deposit an amount of Rs. 8.50 lakh (Eight Lakh Fifty thousand) only for Supply of 2297 units of Pig of body weight 15 to 18 Kg as EMD. Recommended breeds for supply is Large White Yorkshire, Landrace, Tamworth and T&D.

The above mentioned amount of EMD should be submitted in the form of Bank Draft/ Bank Guarantee of any scheduled bank in favour of **"Director, Animal Husbandry, Bihar"** payable at **Patna** and will be placed in cover-1 with technical bid.

The bidders who are registered with the Central Purchase Organisation/State Purchase Organisation, National Small Industries Corporation (NSIC) shall not be liable to deposit earnest money (EMD) in respect of the items covered in their certificate subject to production of attested photocopy of registration certificate.

The small scale units located in Bihar shall not be liable to deposit earnest money (EMD) in respect of the items covered in their certificate subject to production of attested photocopy of registration certificate. But regarding performance security deposit they will have to deposit 20 percent of the general security amount after receiving the purchase order. However, after receiving the purchase order, if they fail to supply the Tender Item, without any appropriate reason, they will be blacklisted as per the procedure laid down.

Payment of Earnest Money in any other form (other than as specified above) shall not be accepted in any case. The bidder shall not be entitled to claim any interest on the Earnest Money.

The Earnest Money deposited by unsuccessful bidders will be refunded as early

as possible after the tenders are finalized. Earnest Money deposited by the successful bidder will be returned after deposit of amount towards Security Deposit or may be adjusted towards Security Deposit, if the bidder wants so. Earnest Money deposited with Director, Animal Husbandry, Bihar, Patna in connection with any other tender even if for same/similar material by the bidder will not be considered against this tender.

The EMD will be forfeited if the bidder withdraws the tender or does not accept the approved list or does not supply the items within the stipulated time as per the terms & conditions of tender or the product supplied is proved to be of substandard quality.

RIGHT OF ACCEPTANCE/REJECTION OF TENDER

The following documents must be submitted by the bidder alongwith tender papers.

1. EMD (Earnest Money Deposit) or necessary document from concerned authority towards exemption of EMD.
2. Attested Photo copy of PAN card.
3. Income Tax return for the last Assessment Years (2019-2020).
4. Attested photocopy of GST Registration Certificate.
5. Detail Name, Address, telephone No., Fax, E-mail, of the firm & of the Authorised Agencies/ Authorised Representatives / Company/ Firm/ Trust/ Society/ Authorised Distributor/ Pig Farm Owners person of the same must be mentioned in the tender form.
6. Attested Photocopy of (i) Original Authorization Certificate (ii) authorized distributors/authorized agencies/ authorized representatives certificate from the Pig Farm Owner for supply of Pigs of recommended breed in case of authorized representatives/ authorized distributor/authorized agency.
7. Attested photocopy of Average Annual Turn Over (Minimum Rs.20.00 Lakh) disclosed in VAT Returns/GST Returns of last one years or Certificate issued by Chartered Accountant to this effect for last one Financial years.
8. Affidavit regarding not blacklisted as well as not facing any enquiry by any Govt. Offices/Govt. undertakings/ organizations (for the bidder).
9. Supply orders in support of experience of supplying the items of Recommended breeds i.e Large White Yorkshire, Landrace, Tamworth and T&D. for not less than one year to Government/semi government/ Private Organizations, bulk purchasers etc.
10. Annexure "II", "III", "IV" and "V" duly filled in.

Documents should be attested by the bidder or their authorized representative.

No tender shall be considered if the same is not supported with the above documents mentioned at Sl. No.1 to 10.

The right of acceptance of tender and award of contract rests with the **Purchase Committee** which does not bind itself to accept the lowest tender and also reserves the right to reject any or all the tender(s) received without assigning any reason

whatsoever. Any dispute arising in future will be finalized by the Principal Secretary/Secretary, Department of Animal and Fisheries Resources, Bihar. The legal dispute is subject to the competent court of justice at Patna only.

PERFORMANCE SECURITY DEPOSIT (GENERAL SECURITY AMOUNT)

1. The successful bidder(s) shall have to furnish the performance security deposit @ 5% of contract value in the form of DD/BG of any commercial bank in favour of **Director, Animal Husbandry, Bihar** & payable at **Patna** only. The EMD deposited by successful bidder may be adjusted towards Security Deposit as demanded above. If the successful bidder fails to furnish the full security deposit within 15 (fifteen) days after the issue of Letter of Award of Work, his bid security (EMD) shall be forfeited unless time extension has been granted by Director, Animal Husbandry, Bihar, Patna.
2. The performance security deposit shall be forfeited if successful bidder fails to supply the goods in stipulated time or fails to comply with any of the terms & conditions of the tender/supply order/agreement or fails to sign the agreement.
3. The small scale units located in Bihar will have to deposit only 20 percent of the general security amount. However, after receiving the purchase order, if they fail to supply the tender item, without any appropriate reason, they will be blacklisted as per the procedure laid down.
4. In the event of failure of payment of Security Deposit, the order is to be treated as cancelled and steps will be taken to place the indent to next approved firm of the tender after due negotiation and after approval from the Govt. The successful bidder shall not be entitled to claim any interest money on the amount of Security Deposit.
5. The Security Deposit will be released & returned back to the bidder after successful supply of the ordered goods. The Security Deposit shall be forfeited in case the item of supply is found to be of sub-standard quality by the competent authority.

VALIDITY OF TENDERS

- 1- All the tenders shall remain valid for acceptance for the financial year 2021-22 or till finalization of the next tender whichever is earlier. If adoption of next approved list is delayed beyond the financial year 2021-22, the terms, conditions and the approved price of the tender item may be extended for a period as desired by the Director, Animal Husbandry, Bihar on recommendation of the Purchase Committee.
- 2- No extension of time shall be allowed for submission of tender under any circumstances unless otherwise specifically extended by the Director, Animal Husbandry, Bihar.

BIDDER'S UNDERSTANDING OF THE TENDER DOCUMENT

The bidder shall carefully go through the tender documents and fully inform himself to all the terms and conditions contained therein before submission of the tender. If the bidder find discrepancies or omission or should be in doubt as to their meaning relating to tender documents, he should at once inform the Director and obtain clarification in writing prior to submission of this tender. Verbal clarification or information given by the Director, Animal Husbandry, Bihar or the employees working under him or his representatives shall not be binding on the Director.

NO CLAIM OF COMPENSATION FOR SUBMISSION OF TENDER

No Bidder shall be entitled to claim any cost, charges, expenses etc. incurred by him or incidental therein connection with submission of this tender even though the Department may elect to withdraw the invitation of Tender, without notice and without assigning any reason whatsoever.

TERMS AND CONDITIONS

FOR SUBMISSION OF TENDER FOR RATE CONTRACT FOR SUPPLY OF PIGS FOR THE YEAR 2021-22

The Bidder should read carefully all the terms & conditions before preparing the tender documents for participation in the tender.

A. Instructions to Bidder while downloading the tender document.

Each set of Tender documents shall be serially page marked. The Bidder should check the documents immediately after downloading of the same. If there are any lapses, the Bidder should immediately report the fact to the Director for its rectification, if any.

B. Instructions to Bidder while submitting the Tender Papers.

1. All the tender documents along with the enclosures should be signed at the bottom by the bidder in each page with date.
2. Capital letters should be used in filling up of the tender form and should be neatly typed/computerized.
3. All corrections, additions, alterations in the tender documents shall be authenticated by initial/ signature of the bidder.
4. Rates should be quoted on the prescribed tender form (Annexure V). The rates offered should be written both in figures and in words and no erasing, cutting or overwriting shall be entertained. Bidder May quote rate for one or more district. Districtwise target is given in Annexure ,Districts for which rate is not received , for such district rate of adjacent district will be valid.
5. All information in these tender documents shall be in English only.
6. Bidder firm should not quote any Breed which is not as per Specification. It is required to submit a certificate with this regard.
7. The rate to be quoted by the bidder should be **F.O.R. destination at Distribution Points as decided by the Beneficiary/ concerned DAHOs under the department, inclusive of all applicable taxes and transportation charges.** The rate should be quoted in **Indian currency** only. It is necessary that specific Breed should be clearly mentioned on the tender paper furnished to compare with the Specification.
8. The Bidder must quote the rate of per unit Pigs as per specification for which they have been specifically asked for as per tender schedule. Bidders quoting the rates different from those mentioned in the tender schedule may be liable to be rejected. Tender containing clerical error/typographical error/ arithmetical mistake (s) may be liable to be rejected.
9. The bidder shall quote the tender price at Col-8 of Annexure-V, which shall be inclusive of all applicable taxes and transportation charges. The GST should be

charged as per guidelines given by the Government.

10. One rate shall be offered for all Breed. The Bidder shall clearly mention the Breed, specification and shall furnish literature /document in proof of Production parameters for each Breed.
11. The price preference for S.S.I. units located inside the state of Bihar will be given in accordance with the Government industrial Policy/Resolution in vogue. The Bidder who are S.S.I. units should submit relevant documents from the competent authority alongwith the tender documents stating the Permanent Registration number and Date and the names of the items for which registered. The words **S.S.I. unit located inside the state of Bihar** should be marked in **Red Ink on the right hand top corner of the Tender documents**.
12. In case two bidder quote L1 price, the bidder belonging to Bihar (having Production unit and rearing unit in Bihar state) would be given preference to promote these enterprise in Bihar.
13. The Tender filled by the proprietorship concerns should be signed by -
the sole proprietor
or
by the managing partner in case of Partnership firm
or
by Managing Director or Board of Directors along with the authorization by means of Board of resolution in case of company.
or
by a person having valid power of attorney on behalf of competent authority in respect to file tenders and to execute all requisite deeds.
In case of Partnership firm, the copy of partnership deed to be submitted duly attested by Gazetted Officer.
Copy of the Certificate of incorporation should be furnished in support of the firm being registered under the companies Act.
14. Submission of more than one Tender by a particular Bidder under different names is strictly prohibited. In case it is found later on that this condition has been violated, all the tenders submitted by such Bidder would be rejected or cancelled and Earnest Money and/or Security Deposit forfeited to Government in addition to such legal action will be taken as deemed fit and proper.
15. Tenders directly received from the Pig Farm Owner will be given preference subject to they have Pig Farm unit in the State of Bihar. Tenders of any firm newly constituted, inexperienced and without credibility will be rejected. The Authorised Agencies/ Authorised Representatives / Company/ Firm/ Trust/ Society/ Authorised Distributor/ Pig Farm Owners having valid registration should have minimum one years experience in supplying Pigs of recommended breed to Govt./Semi government/Private organizations, bulk purchasers etc. Besides, they should have to submit certificate of annual turnover of minimum Rs. 20.00 Lakh in supply of Pigs for preceding 1 years in support of establishing the soundness of the firm and its business credibility towards competition in the

tender.

Also, the bidder shall furnish a brief write-up supported with adequate data and documentary evidence explaining and establishing his credentials, breeding capacity, financial background, past performance, available capacity both technical and financial to perform the supply contract (if awarded) within stipulated time period.

16. **Each page of tender documents besides the places specified should be signed by the bidder or their authorized representative. All signatures should be dated.**

17. **MANNER OF SUBMISSION OF TENDER:-**

All offers shall be addressed to the **THE DIRECTOR, ANIMAL HUSBANDRY, BIHAR, NEW SECRETARIAT, VIKAS BHAWAN, PATNA-800015.**

- i) The Technical Bid along with all documents required to be submitted in a sealed envelope, the top of the cover must be super-scribed with, "**Tender for Rate Contract for Supply of Pigs For the Year 2021-22.**" for Animal Husbandry Directorate, Bihar, Patna and name and address of the bidder on left side of the envelope.
- ii) The financial bid comprising Annexure-V only is to be submitted in another sealed envelope, the top of the cover must be super-scribed with "**Tender for Rate Contract for Supply of Pigs For the Year 2021-22.**" for Animal Husbandry Directorate, Bihar, Patna and name and address of the bidder on left side of the envelope.
- iii) Both the **technical bid** and the **financial bid** should be sealed by the bidder in separate envelope as mentioned above and both these sealed covers are to be put in a bigger envelop which should also be sealed and duly super-scribed "**Tender for Rate Contract for Supply of Pigs For the Year 2021-22.**" on the top of the envelop to be addressed to **The Director, Animal Husbandry, Bihar, New Secretariat, Vikas Bhawan, Patna-800015** and name & address of the bidder should be mentioned on left side of bigger envelope containing both technical bid envelope and financial bid envelope.
- iv) The Tenders in sealed cover should be inserted in the **Tender Box** in the office of the **Director, Animal Husbandry, Bihar** as per time schedule already mentioned in the tender document. If the due date so mentioned above is declared as a holiday by the Govt. of Bihar, the last date and time for submission and opening of tenders shall respectively be the time as aforesaid on next working day.
- v) Tenders sealed and super-scribed as above may also be sent by **Registered Post/Speed Post** addressed to the above authority so as to reach by the due date and time. The tenders received by **Registered Post/Speed Post** will also be inserted in the **Tender Box**.
- vi) The tender which is received after the time and date specified above will not be entertained and is liable to be rejected.

18. Submission of Tender by any other means will not be accepted.
19. The bidders shall quote rates which shall remain valid for acceptance for financial year 2021-22 or till finalization of the next tender whichever is earlier. If adoption of next approved list is delayed beyond financial year 2022-23, the terms, conditions and the approved price of the items in the Tender may be extended for a period as desired by the Director, Animal Husbandry, Bihar on recommendation of the Purchase Committee based on requirement of department and performance of bidder.
20. THE DEPARTMENT PURCHASE COMMITTEE/TENDERING AUTHORITY/UNDERSIGNED RESERVE THE RIGHT:
- To reject any / or all the Tenders at any stage without assigning any reason there of and not to accept the lowest Tender.
 - To invite fresh offers from the open market or negotiate with other bidders quoting higher rate to come down to the lowest rate of the item offered by the competitors in the tenders.
 - To purchase Pigs of recommended breed and weight at the approved rate of the Tender from any outsider during the Tender/ Contract Period in case of as desired by Beneficiary of Department Scheme/ emergency, if the Bidders fail to supply such items on short notice or stops supplying or any other matter.
 - To withdraw the item from the tender at any stage. In such contingency the selection of such item already made in favour of any Bidders already made, shall be treated as cancelled.
 - Not to give price preference to Bidders in compliance with the existing orders issued by this State Government at the discretion of the Purchase Committee.
 - To procure the item of the tender directly from State/Central Govt. Undertaking firms even if a tender of other parties for the same item has been offered/ accepted/approved.
 - To make additions to or deletion from the list of offices of the District Animal Husbandry Officer/delivery points to any time during the period of validity of the tender or of the contract in pursuance of the Tender.
 - To process the tender groups separately.
21. Approval of items of successful Bidders will be notified/issued by the authority in due course. On receipt of such information, the successful bidder(s) has to execute an **Agreement** on Indian non judicial stamp paper of appropriate denomination (as stipulated by the State Govt. of Bihar). He/they is/are also required to furnish the performance security deposit (PSD) @ 5% of the supply order (to be issued by the Beneficiary/concerned DAHO) in the form of DD/BG of any commercial bank in favour of **the concerned District, Animal Husbandry, officer & payable at concerned District Headquarters only.**

In substitute arrangement an **Agreement** on Indian non judicial stamp paper of appropriate denomination (as stipulated by the State Govt. of Bihar) may be executed at Directorate level and performance security deposit (PSD) @ 5% of the

value of Estimated requirement (as inscribed in Tender Document) of the Tender item in the form of DD/BG of any commercial bank in favour of **The Director, Animal Husbandry, Bihar, New Secretariat, Vikas Bhawan, Patna-800015**

The specification and quantity of the item needed as mentioned in the tender notice is tentative and is subject to increase/decrease as per the availability of fund. The payment would be made for actual supply taken and no claim in this regard should be entertained otherwise.

22. The **Supply Order** to the successful bidder will be given by the Beneficiary/Concerned DAHO. In case the successful bidder (L₁) is unable to supply the item(s) in requisite quantity within stipulated time as mentioned in the supply order, for smooth and uninterrupted supply, the supply order may be distributed to more than one party on approved rate. Apart from it, a penalty @1% of the total value of delayed supply will be imposed on the supplier. Payment to the supplier will be made after deduction of penalty amount. The decision of Director, Animal Husbandry, Bihar/ Concerned DAHO will be final in this regard.

The successful bidder will have to supply the item(s) to the Distribution Points as decided by the concerned District Animal Husbandry Officers under the department/Beneficiary in accordance with the conditions mentioned in the Tender Notice, Agreement and Supply Order. 32.
