

**(A) Information and conditions relating to submission of Bids -**

1. The tender document containing eligibility criteria, scope of work, terms & conditions can be downloaded from website :- <https://state.bihar.gov.in/ahd>.
2. The interested firms/suppliers are required to submit the Technical and Financial Bids in two separate sealed envelopes in the format enclosed and then these two envelopes are to be put in one common sealed envelope super-scribed "**Tender For Artificial Insemination Kits (A.I.Kits)**" and send it by hand or by registered post so as to reach the office of The Project Director, Bihar Livestock Development Agency, Patna, P.O-Bihar veterinary college, Patna-800014 by or before **08/10/2021 till 1.00 PM** . The Technical bids shall be opened on the same day at **03.00 PM** in the office of the Project Director, BLDA, Patna. Bidders may be presence or their authorized representatives in this meeting. The Tender received after due date & time will be rejected and no claim shall be entertained whatsoever may be the reason.
3. The bidders are required to submit their query in writing before **27/09/2021** to the Project Director, BLDA, Patna, if any.
4. All the duly filled/completed pages of the tender should be given serial /page number on each page and signed by the owner of the firm or his authorized signatory. In case the Authorized signatory signs the tenders, a copy of the power of attorney/authorization enclosed on the letter head of the company along with tender.
5. A copy of the terms & conditions shall be signed on each page and submitted with the technical bid as token of acceptance of terms & conditions. Tender with unsigned pages/ incomplete/ partial/part of tender if submitted will be rejected out rightly.
6. All entries in the tender form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting is permitted in the Technical Bid as well as Financial Bid unless authenticated by full signature of bidder. Any omission in filling the columns of Financial Bid form (Schedule of Rates) shall debar a tender from being considered. Rates should be filled up carefully by the tenderer. All corrections in this schedule must be duly attested by full signature of the tenderers. The corrections made by using fluid and overwriting will not be accepted and tender would be rejected.
7. The bidder shall pay an amount of **Rs- 1.25 Lakh (Rupees One lakh twenty five thousand only) for Artificial Insemination Kits (A.I.Kits)** as Bid Security (EMD) along with the Technical Bid in the form of DD in favour of "**Project Director, Bihar Livestock Development Agency, Patna**" drawn on any Nationalized Bank/ Scheduled Bank and payable at **Patna**. Bids received without EMD shall stand rejected and thus shall not be considered for evaluation etc. at any stage. The original EMD will be put in cover-I containing **Technical bid**.

- a. The Public Sector under taking of the Central/State Govt. is exempted from furnishing Earnest Money along with tender. It is compulsory to attach documentary proof for the same. Otherwise their tender will be cancelled straightway.
  - b. The manufacturer firms Registered with MSMEs are also exempted from furnishing Earnest Money provided that they have MSME certificate of relevant items mentioned in the tender. It is compulsory to attach documentary proof for the same. Otherwise their tender will be cancelled straightway. Traders are excluded from the purview of this Policy.
  - c. Earnest Money deposited with **Project Director, BLDA, Patna** in connection with any other tender even if for same/similar material by the tenderer will not be considered against this tender.
8. The bid security (EMD) without interest shall be returned to the unsuccessful bidders within 60 days from finalization of the tender.
  9. The successful bidder(s) has to execute an **Agreement** on Indian non judicial stamp paper of appropriate denomination (as stipulated by the State Govt. of Bihar) and also required to furnish the performance security deposit @ 5% of contract value in the form of Bank Guarantee of any nationalized bank in favour of **Project Director, Bihar Livestock Development Agency** payable at **Patna** only. This Bank Guarantee will be valid till 60 days beyond the completion of the supply contact period. The EMD deposited by successful bidder shall be returned after submission of performance Security Deposit Bank Guarantee. If the successful bidder fails to furnish the full performance security deposit within 15 (fifteen) days after the issue of Letter of Award of Work, his bid security (EMD) shall be forfeited unless time extension has been granted by Project Director, BLDA, Patna.
  10. The performance security deposit shall be forfeited if successful bidder fails to supply the goods in stipulated time or fails to comply with any of the terms & conditions of the tender/supply order/agreement.
  11. The bid shall be valid and open for acceptance of the competent authority for six(6) months from the date of opening of tender and no request for any variation in quoted rates and / withdrawal of tender on any ground by bidders shall be entertained.
  12. To assist in the analysis, evaluation and computation of the bids, Project Director, BLDA, Patna may ask bidders individually for clarification of their bids. The request for clarification and the response shall be in writing but no change in the price or substance of the bid offered shall be permitted.
  13. After evaluation, the order shall be awarded normally to the firm fulfilling all the conditions and who has quoted the lowest rate as per financial bid after complying with the all the Acts / provisions stated / referred to for adherence in the tender.
  14. Project Director, BLDA, Patna reserves all rights to accept or reject any/ all tender(s) without assigning any reason. He can also impose, relax, verify, modify, revise, amend or change any term and conditions mentioned above without assigning any reason whatsoever thereof or may terminate the Bid process mid-way without assigning any reason. Project Director, BLDA, Patna also reserves the right to reject any bid, which in his opinion is non-responsive, or violative of any of the conditions/ specifications

without any liability to any loss/damage whatsoever it may cause to the bidder in the process. The corrigendum will be published on the website only.

- 15. Tenderers must be submitted on the prescribed format and procedure otherwise tender will be cancelled straightway.
- 16. Canvassing in any form is strictly prohibited and the tenderers who are found canvassing are liable to have their tenders rejected out rightly.

**(B) ELIGIBILITY CRITERIA OF THE TENDER :**

- 1. The item(s) quoted should be of high quality and standard as per given details specifications & quantity in Annexure-II. Inferior quality not accepted straightway.
- 2. The rate quoted by the tenderer shall be valid for at least **two year** from the date of signing of the contract which may be extended on performance basis for further one year or till the finalization of the next tender.
- 3. Bidders are required to carefully go through the instructions included in the document and furnish complete information, necessary documents and schedules duly filled in as per Annexure-III and attached with Technical bid.
- 4. All the duly filled/completed pages of the tender should be given serial /page number on each page and signed by the owner of the firm or his authorized signatory.
- 5. Please attach Power of Attorney/authorization letter for signing the bid documents on letter head of the company/Agency in case of authorized signatory / representative.
- 6. Annexure-I Covering letter in the letter head pad of the Tenderer should submit along with the tender.
- 7. The tenderer has to make a set/bundle of AI Kit by putting items no. (ii) to (xviii) in a bag mentioned in item no. (i). However, purchaser reserves the rights to evaluates the entire bid considering the supply as single lot. Please be noted that entire evaluation for AI Kit will be done in one bundle/set.
- 8. Tenderers will have to fix an identification mark such as name of firm/logo etc. on their samples or mark their samples by permanent marker.
- 9. It is compulsory for the bidder to provide a set of such samples of each item mentioned in AI Kit along with offer as per exact specification (Annexure-II). The technical finalization of bid will be done only if the samples exactly match with their specifications.
- 10. In the first meeting of technical bid only document assessment will be taken up. The inspections of samples will be done in the next meeting for only those tenderers who have qualified the document assessment successfully. The samples and financial bids of those tenderer who have not qualified in document assessment will not be opened. Their samples and financial bid envelop will be returned back to them without opening. The financial bids of only those tenderers will be opened who have qualified the document assessment and sample inspection successfully.
- 11. The intimation of date of meeting for sample inspection shall be given later on.
- 12. The bid of the tenderer will be disqualified technically, If:-
  - any items of samples do not match with the specifications mentioned in bid.
  - any items of samples are of low quality.
  - tenderer has not provided any samples of items of AI kit.

13. The sample of bidder selected for L1 shall be kept in the office for matching it with the goods/materials supplied. Supply should be made according to the approved sample. Rest all other bidders will have to take back their samples from our office within one month of finalization of tender on their own expenses/cost. BLDA will not be responsible for returning or loss of the sample after that.
14. In the event of non-submission of sample, it will be treated as unwillingness /inability to supply and such tender will not be considered.
15. Only those bidders will be considered for selection of L1, who will quote rates for all eighteen (xviii) items mentioned in AI Kits. If any items of the AI Kit are missing in list of quoted rates of bidder the tender of that bidder will not be considered in Financial bid.
16. The bidder shall pay an amount of **Rs- 1.25 Lakh (Rupees One lakh twenty five thousand only) for Artificial Insemination Kits (A.I.Kits)** as Bid Security (EMD) along with the Technical Bid in the form of DD in favour of **"Project Director, Bihar Livestock Development Agency, Patna"** drawn on any Nationalized Bank/ Scheduled Bank and payable at **Patna**.
17. The tenderers should furnish a copy of PAN and GST registration number. Tenders not complying with this condition will be rejected.
18. The tenderers should submit along with the tender, a photo copy of the Income Tax returns for the last three (3) years.
19. The tenderers should submit along with the tender, a photo copy of the balance sheet (duly certified by Chartered Accountant) for the last three (3) years (2017-18, 2018-19 & 2019-20). UDIN must be mentioned on Balance sheet of F.Y. 2018-19 & 2019-20. Minimum Annual turnover should not be less than 2.00 (two) crores in each year.
20. Please submit a self declaration on pad that no case is pending with the police against the Proprietor/firm/partner or the Company (Agency) Please also declare that proprietor/firm has never been black listed by any organization and non compliance of the order.
21. List of items with full description & specifications, make/brand name must be clearly mentioned in the Annx.II of tender.
22. A copy of the terms & conditions of tender document shall be signed on each page and submitted with the technical bid as token of acceptance of terms & conditions. Tender with unsigned pages/ incomplete/ partial/part of tender if submitted will be rejected out rightly.
23. Please submit relevant proof previously supplied these types of items to any government/semi government/ reputed private organization.
24. Please provide a notarized affidavit on Indian Non Judicial stamp paper of appropriate denomination that you have not quoted the price higher than previously supplied (during last three months from the date of fillings this tender) to any government Institute/ Organization/ reputed Private Organization, DGS&D rate or MRP/Market Price.
25. The tenderers should submit self attested photo copy of a valid character certificate issued by Superintendent of Police / Senior Superintendent of Police for bidders of Bihar state or valid Police Clearance Certificate (PCC)/ character certificate issued by

The date of issue of the character certificate/PCC should not be more than six (6) months old.

**(C) OTHER TERMS & CONDITIONS OF THE TENDER:**

1. Conditional tenders/incomplete tenders will be straightway rejected.
2. The decision of technical committee will be based on basis of verification of documents and samples as per bid. The decision of committee will be final and all bidders will be bound to accept it. Only the technically approved offers will be opened for financial evaluation.
3. Rates quoted should be inclusive of all charges as packing, packaging, forwarding, and postage and transportation charges at FOR destination (Bihar Livestock Development Agency, Patna, P.O-Bihar veterinary college, Patna-800014). **Rates are to be quoted both for the unit price and applicable GST in Tech Form-IV.**
4. All the rates should be mentioned in Indian National Currency (INR) only. The rates quoted in foreign currency will not be entertained in this tender enquiry & such tenders will be cancelled straightway.
5. More than one rates for one item will not be acceptable.
6. Rates should be mentioned both in figures and in words separately. The offer should be typed or written in Ink Pen/ Ball Pen without any correction. Offers in pencil will be cancelled. Email/Telegraphic / Fax offers will not be considered and cancelled straightway.
7. The time for the date of delivery/ dispatch stipulated in supply order shall be deemed to be essence of the contract and if the supplier fails to deliver or dispatch any consignment **within 45 days from the supply order** or the period and manner prescribed for such delivery or dispatch in the supply order, liquidated damages may be deducted from the bill @ 0.5% per complete week subject to maximum of 10% of the value of the delayed goods under the contract. Project Director, BLDA, Patna may also cancel the supply order. In such a case, whole performance security amount of the supplier shall stand forfeited.
8. In case the quality of goods supplied are not in conformity with the standard given in tender or the supplies are found defective at any stage these goods shall immediately be taken back by the supplier and will be replaced with the tender quality goods, without any delay. The competent authority reserves all rights to reject the goods if the same are not found in accordance with the required description / specifications and liquidated damages shall be charged as specified.
9. In case the tenderer on whom the supply order has been placed, fails to make supplies within the delivery schedule and the purchaser has to resort to risk purchase, the purchaser (Project Director, BLDA, Patna) may recover from the tenderer the difference between the cost calculated on the basis of risk purchase price and that calculated on the basis of rates quoted by tenderer.

10. The specification and quantity of the item needed as mentioned in the tender notice is tentative and is subject to increase or decrease at the discretion of the Project Director, BLDA, Patna. The payment would be made for actual supply taken and no claim in this regard should be entertained otherwise.
11. The contract/Purchase order will be awarded to the successful bidder, whose bid has been technically qualified and lowest commercially acceptable bid.
12. The supply order to the successful bidder will be given by the Project Director, BLDA, Patna. In case the successful bidder (L<sub>1</sub>) is unable to supply the item within stipulated time, the supply order may be given to other party on approved rate having the similar specification. The successful bidder will have to supply the item to Bihar Livestock Development Agency, Patna-14 in accordance with the conditions mentioned in the Tender Notice, Agreement and Supply Order.
13. Delivery challan/Bill in triplicate must be submitted along with the consignment.
14. Payment against all the accepted supplies will be made by Project Director, BLDA, Patna.
15. No advance payment would be entertained.
16. 100% payment will be made within 60 days against physical delivery of inspected / accepted goods duly supported with satisfactory inspection note and after receipt of correct goods at Consignee's site. Physical verification and inspection of the supplied item(s) will be done by the Project Director, BLDA, Patna or concerned requisition officer.
17. The terms and conditions mutually agreed upon shall be subject to **Force Majeure** clause. Neither the supplier nor the purchaser shall be considered in default in performance of its obligations hereunder, if such performance is prevented or delayed by war, hostilities, revolution, civil commotion, strike, epidemic, accident, fire, wind, flood, earth quake or because of any law proclamation, regulation or ordinance of any Government or of any act of God or of any other cause whether of similar or dissimilar nature, beyond the reasonable control of the party affected. Should one or both the parties be prevented from fulfilling his/their obligations by a state of **Force Majeure** lasting continuously for a period of six months, the two parties shall consult each other regarding the future execution of the purchase orders.
18. Project Director, BLDA, Patna reserves all rights to accept or reject any/ all tender(s) without assigning any reason. He can also impose, relax, verify, modify, revise, amend or change any term and conditions mentioned above without assigning any reason whatsoever thereof or may terminate the Bid process mid-way without assigning any reason. Project Director, BLDA, Patna also reserves the right to reject any bid, which in his opinion is non- responsive, or violative of any of the conditions/ specifications without any liability to any loss/damage whatsoever it may cause to the bidder in the process. The corrigendum will be published on the website only.
19. All decisions taken by the committee of BLDA regarding the processing of this Bid and award of contract shall be final and binding on all concerned parties.
20. The decision taken by the Project Director, BLDA, Patna in the process of Bid evaluation will be full and final and binding on all the bidders.

If any dispute or differences arise at any time between the two parties in respect of or concerning anything herein contained or arising out of the agreement or as to the rights, liabilities or duties of supplier and Project Director, BLDA, Patna the same shall be referred to the sole Arbitrator, the Principal Secretary/Secretary, Department of Animal & fisheries Resources, Bihar, Patna. The decision of the Arbitrator shall be final and binding on all the parties. The venue of the arbitration shall be at Patna, (Bihar, India). The arbitrator will give reasoned decision.
