TECHNICAL CRITERIA

1. Supply shall comprise supply of Pigs, as per specification supported by a declaration certificate from Registered Veterinary Practitioner on characteristics of Pigs, breed, age, body weight, health status, recorded and duly authenticated at the time of supply. **The veterinarian at the receipt point, on physical examination has full right to reject any unfit animal** and supplier has to take it back immediately at his/her own cost and responsibility.
2. Supply shall comprise with detailed health status duly certified by Concerning Touring Veterinary Officer (TVO) of Block H.Q. and authorized by district administration (DAHO).

TECHNICAL SPECIFICATION FOR THE ANIMALS TO BE PURCHASED:

- i **Animal & Breed:** Pigs of Large White Yorkshire/ Landrace/ Tamworth/ T&D or Jharsuk breed.

ELIGIBILITY CRITERIA

Bidder intending to Bid shall fulfill the following eligibility criteria to supply Pigs all the District Head Quarter of Bihar.

- a) May be Institution/ Farm (S)/ Self Help Group/ Society registered with any Government organization/ individual Pig vendor etc. having such business including Pig Rearing Farm and capable to supply of Pigs all over Bihar.
- b) Proof of Financial Status in the form of balance sheet/ITR of Form/ Vendor having own Pig Rearing Farm in regard to the business for the Assessment Year 2022-23 2023-24 & 2024-25.
- c) Should have not been banned/ blacklisted/ temporarily suspended by any Government Department/Organization.
- d) The bidder should submit Proof of supply of pigs as experience.
- e) The bidder should submit Pan and Aadhar Copy.
- f) The bidder should submit self declaration regarding supply of maximum nos of Female Pig (Sow) and Male Pig (Boar) (age of not less than 3 months and each Female Pig (Sow) Body weight 20 Kg and above & each Male Pig (Boar) Body weight 25 Kg and above) in FY 2024-25 & 2025-26.
- g) Empaneled bidder have to supply same breed of Pigs in a unit.
- h) Empanelment of bidder will be listed after scrutiny of the documents.

The list of the empaneled bidder will be distributed with the list of the districts to which they will have to supply Large White Yorkshire/ Landrace/ Tamworth/ T&D or Jharsuk breed of Female Pig (Sow) and Male Pig (Boar) (age of not less than 3 months and each Female Pig (Sow) Body weight 20 Kg and above & each Male Pig (Boar) Body weight 25 Kg and above) as per the decision of the Technical Committee formed at the Directorate level and the suppliers & districts both will abide that the supplier will supply Pig as per the requirement of assigned districts. The districts can order to more than one supplier for supply of Pigs. Accordingly agreement will be made and indent will be placed to the

empaneled suppliers. Supply of Pigs with mentioned numbers to the destination point are to be completed within 60 (sixty) days of supply order by Director, Animal Husbandry, Bihar to the successful bidder.

3. Payment against all the accepted supplies will be made by the **the concerned District, Animal Husbandry, officer/Beneficiary.** Payment will be made soon after completion of particular supply order. No advance payment will be entertained in any circumstances.

(A)-For submission of tender -

There shall be Single bid system - **Only Technical-bid**

Technical Bid:- The bidder shall submit tender form, details regarding the firm along with attested photocopies of relevant documents, details regarding the item to be supplied along with attested photocopies of relevant documents and check-list in a sealed envelope.

(B) Bidders shall submit (along with their Bids) EMD in the form of a Bank Guarantee (BG)/ Fixed Deposit Receipt (FDR) in favour of "Director, Animal Husbandry, Bihar payable at Patna and should be valid for 6 months. No interest shall be payable on Bid Security under any circumstance.

(C) EARNEST MONEY DEPOSIT (EMD)

The bidder is required to deposit an amount of **Rs. 9.80 lakh (Nine Lakh Eighty Thousand) only as EMD** for Supply of 2510 units of Pigs of age not less than 3 months and each Female Pig (Sow) Body weight 20 Kg and above & each Male Pig (Boar) Body weight 25 Kg and above. Recommended breeds for supply is Large White Yorkshire/ Landrace/ Tamworth/ T&D or Jharsuk.

The bidders who are registered with the Central Purchase Organisation/State Purchase Organisation, National Small Industries Corporation (NSIC) shall not be liable to deposit earnest money (EMD) in respect of the items covered in their certificate subject to production of attested photocopy of registration certificate.

Micro and Small Enterprises (MSEs) situated and operated in Bihar and acknowledged with UDYAM Registration in respect of the item covered in their certificate including start-ups (as defined in Bihar start-up Policy 2022 as amended from time to time) are exempted from payment of Earnest Money Deposit.

Payment of Earnest Money in any other form (other than as specified above) shall not be accepted in any case. The bidder shall not be entitled to claim any interest on the Earnest Money.

The Earnest Money deposited by unsuccessful bidders will be refunded as early as possible after the tenders are finalized. Earnest Money deposited by the successful bidder will be returned after deposit of amount towards Security Deposit or may be adjusted towards Security Deposit, if the bidder wants so. Earnest Money deposited with Director, Animal Husbandry, Bihar, Patna in connection with any other tender even if for same/similar material by the bidder will not be considered against this tender.

The EMD will be forfeited if the bidder withdraws the tender or does not accept the approved list or does not supply the items within the stipulated time as per the terms & conditions of tender or the product supplied is proved to be of substandard quality.

PERFORMANCE SECURITY DEPOSIT (GENERAL SECURITY AMOUNT)

1. The successful bidder(s) shall have to furnish the performance security deposit @ 5-10% of contract value in the form of BG/FDR of any Nationalized bank in favour of **Director, Animal Husbandry, Bihar** & payable at **Patna** only. The EMD deposited by successful bidder may be adjusted towards Security Deposit as demanded above. If the successful bidder fails to furnish the full security deposit within 15 (fifteen) days after the issue of Letter of Award of Work, his bid security (EMD) shall be forfeited unless time extension has been granted by Director, Animal Husbandry, Bihar, Patna.
2. The performance security deposit shall be forfeited if successful bidder fails to supply the Tendered item(s) in stipulated time or fails to comply with any of the terms & conditions of the tender/supply order/agreement or fails to sign the agreement.
3. Special Category of Enterprises (MSEs) will have to deposit 50% of the performance security amount. However, if they fail to supply after receiving the purchase order without any appropriate reason action will be taken against them as per the extant provision of the Bihar Financial Rules (as per Bihar Purchase Preference Policy, 2024).
4. In the event of failure of payment of Security Deposit, the order is to be treated as cancelled and steps will be taken to place the indent to next approved firm of the tender after due negotiation and after approval from the Govt. The successful bidder shall not be entitled to claim any interest money on the amount of Security Deposit.
5. The Security Deposit will be released & returned back to the bidder after successful supply of the ordered goods. The Security Deposit shall be forfeited in case the item of supply is found to be of sub-standard quality by the competent authority.

BIDDER'S UNDER STANDING OF THE TENDER DOCUMENT

The bidder shall carefully go through the tender documents and fully inform himself to all the terms and conditions contained therein before submission of the tender. If the bidder find discrepancies or omission or should be in doubt as to their meaning relating to tender documents, he should at once inform the Director and obtain clarification in writing prior to submission of this tender. Verbal clarification or information given by the Director, Animal Husbandry, Bihar or the employees working under him or his representatives shall not be binding on the Director.

NO CLAIM OF COMPENSATION FOR SUBMISSION OF TENDER

No Bidder shall be entitled to claim any cost, charges, expenses etc. incurred by him or incidental therein connection with submission of this tender even though the Department may elect to withdraw the invitation of Tender, without notice and without assigning any reason whatsoever.


❖ **The Bidder should carefully read all the terms & conditions before preparing the tender documents for participation in the tender.**


- (1) Technical specification of animal as specified above duly signed by bidder and certified by a registered TVO of Concerned Block/Competent Authority should be produced for each consignment of supply.
- (2) The bidder must supply Large White Yorkshire/ Landrace/ Tamworth/ T&D or Jharsuk breed of Female Pig (Sow) and Male Pig (Boar) age of not less than 3 months and each Female Pig (Sow) Body weight 20 Kg and above @ Rs.6000/-& each Male Pig (Boar) Body weight 25 Kg and above @ Rs.7500/-inclusive of all cost (including transportation cost etc.) up to District level.
- (3) Bidder will have to facilitate arrangement of feeds/fodder along with water at delivery point till supply is completed.
- (4) The Tender filled by the proprietorship concerns should be signed by -
the sole proprietor
or
by the managing partner in case of Partnership firm
or
by Managing Director or Board of Directors along with the authorization by means of Board of resolution in case of company.
or
by a person having valid power of attorney on behalf of competent authority in respect to file tenders and to execute all requisite deeds.
In case of Partnership firm, the copy of partnership deed to be submitted duly attested by Gazetted Officer.
Copy of the Certificate of incorporation should be furnished in support of the firm being registered under the companies Act.
- (5) All the laws related to transport etc. should be followed as per the Rules under Animal Welfare and guidelines by Government of India.
- (6) Supplier will supply the pigs in Co ordination with Concerned DAHO.
- (7) If any diseased / unfit Pig is detected at time of supply, the supplier will immediately remove such animal (s) from the delivery point at his/her own cost.
- (8) Animals not fulfilling the technical specification at the time of delivery, acceptance will be rejected and the bidder will have to take back such animal(s) at his/her own cost.
- (9) Supply with any deviation from the requisite specification will be rejected. In case where payment is not required to be released the same shall be forfeited to Govt. Besides the above, action will be initiated for black listing Firm/ supplier/Bidder on the report of the competent authority.
- (10) The terms and conditions mutually agreed upon shall be subject to **Force Majeure** clause. Neither the supplier nor the purchaser shall be considered in default in performance of its obligations hereunder, if such performance is prevented or delayed by war, hostilities, revolution, civil commotion, strike, epidemic, accident, fire, wind, flood, earth quake or because of any law proclamation, regulation or ordinance of any

Government or of any act of God or of any other cause whether of similar or dissimilar nature, beyond the reasonable control of the party affected. Should one or both the parties be prevented from fulfilling his/their obligations by a state of *Force Majeure* lasting continuously for a period of six months, the two parties shall consult each other regarding the future execution of the purchase orders.

- (11) All provision as stipulated in Bihar Purchase Preference Policy, 2024 notified vide Bihar Gazette extraordinary issue published by Bihar Government (No. Patna 749) and notification no. M-4-03/2021-8550/F, dated 07-08-2024 of Finance Department, Govt. of Bihar, will be followed while finalizing the tender.
- (12) If any dispute or differences arise at any time between the two parties in respect of or concerning anything herein contained or arising out of the agreement or as to the rights, liabilities or duties of supplier and the Director, Animal Husbandry, Bihar, Patna, the same shall be referred to the sole Arbitrator, the Principal Secretary/Secretary, Department of Animal & Fisheries Resources, Bihar, Patna. The decision of the Arbitrator shall be final and binding on all the parties. The venue of the arbitration shall be at Patna, (Bihar, India). The arbitrator will give reasoned decision.
- (13) Any legal dispute is subject to judicature of Patna High Court only.
