No:- 1/Astha (2) 04/2019-3988.....In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Bihar hereby makes the following amendments to the "**Bihar Animal Husbandry Service (Appointment and Service conditions) Rules, 2014**" (as amended from time to time) :-

1. **Short Title , Extent and Commencement :-**
 - (i) These rules may be called the "**Bihar Animal Husbandry Service (Appointment and Service Conditions) (Amendment) Rules, 2025**".
 - (ii) These rules shall be applicable throughout Bihar.
 - (iii) These rules shall come into force from the date of its publication.
2. **Amendment in Rule-5 of the Bihar Animal Husbandry Service (Appointment and Service Conditions) (Amendment) Rules 2020.** —
Rule-5 of the said rule shall be substituted as follow :-

"5. Qualification for Appointment by Direct Recruitment:-

Appointments to general and special posts in the service shall be made through direct recruitment based on the following eligibility criteria :-

- (1) The minimum educational qualification for appointment shall be B.V.Sc. or B.V.Sc. & A.H. degree from a university recognized by Veterinary Council of India.
 - (i) Merit list for appointment shall be determined as follows :-

Full Marks.
 - (a) Marks obtained in the written examination conducted by the commission-

75 Marks.
- Note:-** The weightage of written exam marks will be calculated by multiplying the marks obtained by 0.75.
- (b) Maximum preference for working on contract basis- 25 Marks.

(5 marks for each working year with a maximum limit of 25 marks. For marks of any year, the proportional marks obtained by multiplying the number of working days by 5 and dividing by 365 shall be added)

Total - 100 Marks.

- (2) But the maximum age limit of the candidate on 1st. August of the advertisement year shall be that which may be decided by the State Government (General Administration Department) from time to time reservation category wise.

But in respect of maximum age limit, relaxation as prescribed by General Administration Department's Circular No. 212 dated 23.01.2006 shall be admissible.

Provided also that relaxation in maximum age limit will be given for the period equivalent to the work done as a result of contract employment. Part of any working year will also be included in this. However, the benefit of relaxation in the mentioned age limit and preference in appointment on the basis of work experience will be given only at the time of regular appointment on the post on which work has been done under contract employment.

- (3) For preference of work done on the same post on contract basis or relaxation in maximum age limit, work experience done on the same post in Bihar Government or any non-private institution (such as Government of India/any under taking/corporation/body/authority/autonomous body) within the state of Bihar will be valid. In addition to that, equal weightage for work experience will be given to those veterinary doctors working in different projects under Animal and Fisheries Resources Department, Bihar and veterinary doctors working in any other department of Government of Bihar.
- (4) The work period on contract basis will be decided on the basis of salary payment certificate issued by the concerned controlling officer. For this, the period till the cut-off date mentioned in the advertisement published by the Commission can be calculated for work experience.
- (5) The candidate should be permanently registered with Bihar Veterinary Council.

Note:- (a) (1) The final merit list of the selected candidates will be prepared by the Commission on the basis of the total marks obtained in the written examination and work experience and the reservation category wise recommendation for appointment will be sent to the Department.

- (2) Only the subjects included in the B.V.Sc. & A.H. syllabus will be included in the examination. The format of the competitive examination, syllabus and all other decision related to the conduct of the examination will be taken by the Commission, but if the Commission conduct the competitive examination on more than one date/session as per requirement, the Commission will be able to normalize the marks of different dates/sessions as per requirement.
- (3) 50% horizontal reservation will also be applicable in all reservation categories for candidates passing from veterinary colleges located within the state of Bihar.
- (b) The minimum marks for the candidate considered for appointment in the General/Specialist cadre will be as per the marks prescribed in the circulars issued by the General Administration Department from time to time.
