No-6-N-07-35/2010(Part)-...1005(6)...../ In exercise of powers conferred under proviso to Article-309 of the Constitution of India, the Governor of Bihar is hereby making the following amendments in the “Bihar Lady Health Worker (Auxiliary Nurse Midwife) Cadre Rules, 2025” under the Health Department the “Bihar Lady Health Worker (Auxiliary Nurse Midwife) Cadre amendments Rules, 2025”:-

**1. Short title, extent and commencement.-**

- (i) These Rules may be called the “Bihar Lady Health Worker (Auxiliary Nurse Midwife) Cadre (Amendment) Rules, 2025”.
- (ii) It shall extend to the whole of the State of Bihar.
- (iii) It shall be deemed to have come into effect on 16.11.2018.

**2. Rules 22(ii) of the “Bihar Lady Health Worker (Auxiliary Nurse Midwife) Cadre (Amendment) Rules, 2025” is substituted by the following:-**

Notwithstanding such repeal anything done or any order passed which has attained finality resulting in creating of

vested Rights shall be deemed to have been done under present Rules.

“Provided further, that any appointment made, before or after the amendment of this rule, under 2023 Rules and Pursuant to the selection process commenced on 28.07.2022 shall not be affected and shall be deemed to be an appointment made under these Rules.”
