NOTICE INVITING E-TENDER

(Through e-Procurement mode only on website <https://eproc2.bihar.gov.in>)

The ICDS Directorate, Bihar, invites proposals from reputed and experienced Bidders(OEM/Reseller) to participate in the online competitive e-tender process for the “Procurement of Set of Utensils for Anganwadi Centres” across the State of Bihar.

1. Details of Work

5. The ICDS Directorate, Bihar, reserves the right to accept or reject any tender offer, or to cancel the entire tender process, without assigning any reason thereof.
6. The Bid validity period will be 180 days.
7. The bidder must be Original Equipment Manufacturer (OEM) / Reseller having legal entity registered with a valid Certificate of Registration under the applicable laws.
8. The Joint Venture/Consortium/Subletting in any form will not be allowed.
9. The Bidder (OEM/Reseller) should be in the business of utensils for at least 05 years.
10. The Manufacturer's Authorization Certificate is mandatory for any Bidder other than the OEM. In case a Reseller submits a bid with OEM authorization, the same OEM shall not be permitted to participate separately in the bidding process. If both the Reseller and the OEM apply in the same bid, the participation of both shall be summarily rejected.
11. The Bidders are requested to register on the e-procurement process. The bidder shall get themselves registered with service provider (BELTRON, Bihar) so that User ID, Password and Digital Signature are issued to them. This will enable them to access the website <https://eproc2.bihar.gov.in> and download/participate in e-tender.
12. 13. E-Tender can be downloaded or uploaded only on website <https://eproc2.bihar.gov.in> .
14. The e-Procurement portal (<https://eproc2.bihar.gov.in>) will not accept any bid after the last date and time prescribed for submission of bids. The ICDS Directorate shall not accept any hard copy of the bid, nor shall it entertain any request for consideration of bids submitted after the deadline on account of technical problems or any other reason. Bidders are, therefore, advised to submit their bids well in advance to avoid last-minute contingencies.
15. The Bidders shall submit their eligibility and qualification details for the Bid in the online standard formats displayed in e-Procurement website. The Bidders shall upload the scanned copies of all the relevant certificates, documents etc., in support of their eligibility criteria/technical bids and other certificates /documents on the e-Procurement website.

16. The Bidder shall sign on every statement, documents, certificates, uploaded/attached by him/her, owning responsibility for their correctness/authenticity.
17. Bid Processing Fee, Cost of Tender document and Earnest Money Deposit (EMD) has to be paid through e-payment mode (Online mode) only.
18. The bidder (OEM/Reseller) should make sure the download ability/visibility of uploaded scan document.
19. Bihar Purchase Preference Policy, 2024 will be applicable on this bid.
20. No Bidder shall be permitted to submit more than one Bid for the same work/same NIT number.
21. Any Addendum or Corrigendum issued shall be in writing and attached/uploaded on the e-procurement platform (<https://eproc2.bihar.gov.in>), forming an integral part of the Tender Document. Bidders are required to monitor the e-Procurement portal regularly to track any Addenda/Corrigenda issued by the Tender Inviting Authority. The Tender Inviting Authority shall not be responsible for any claims or issues arising from a bidder's failure to do so.
22. The Bidder (OEM/Reseller) must possess a valid industry license issued by the Industries Department, Bihar, in compliance with the Bihar Purchase Preference Policy 2024 (If applicable). In addition, local bidders are required to furnish a certificate from the Industries Department, Bihar, confirming their manufacturing capacity to meet the requirements specified by the Buyer.
23. During or before participating and uploading the bids during the Bid Stage, Bidders are advised to understand the scope and technical details of the work in greater detail, and to carry out, at their cost, such studies as may be required in submitting their respective Bids for award of the contract including execution and implementation of the Project.
24. The Bidder shall submit sealed samples, comprising one piece each of the 14 types of utensils listed in the specifications sheet (Section-1/Annexure-X) of the tender document.
25. The Testing Fee for sealed samples of Utensils submitted with the Bid shall be **Rs. 1,00,000/- (Rupees One Lakh Only) (Non-Refundable)** to be paid in the form of Bank Draft, in favour of “**DIRECTOR ICDS DIRECTORATE**”, payable at “**PATNA**”.
26. The sealed sample of set of utensils along with required Bank Draft must be submitted at the ICDS Directorate within 24 hrs after the last date of Bid submission.
27. The sample of Utensils shall be sent to a Central Government laboratory for testing. Only those bidders whose samples successfully qualify in the laboratory test shall be eligible for opening of the Technical Bid, while the bids of unsuccessful bidders shall be rejected.
28. The bid may be subjected to splitting.

29. The Purchaser reserves the right to increase or decrease the quantity of items to be ordered by up to 20% at the time of placement of the final contract. The Bidders (OEMs/Resellers) shall be bound to accept and execute the order accordingly.
30. The product shall be supplied to **544 CDPO offices** across the State of Bihar within three months (**90 days**) from the date of issuance of the supply order. The quoted cost of goods shall be inclusive of all applicable taxes, duties, samples, testing, transportation charges etc. and any other incidental expe.
31. The Bid Processing Fee, Cost of Tender Document and the Testing Fee for the sealed sample of Utensils submitted with the bid are non-refundable.
32. The Bidder (OEM/Reseller) Turnover Criteria: The minimum average annual financial turnover of the Bidder (OEM/Reseller) in the last three years, ending on 31st March of the previous financial years (2021-22, 2022-23 & 2023-24) should be 50% of the estimated Bid value. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Registered Chartered Accountant/Cost Accountant indicating the turnover details for the relevant period shall be attached with the bid.
33. Estimated value of Bid is Rs. 11500.90 lakh (Rupees One Hundred Fifteen Crore Ninety Thousand Only).
34. The Bidder(OEM/Reseller) should have supplied same or similar Category Products for **30% of bid value** within last **5 years** before the bid opening date to any Central/State Govt./UT Organization/PSU. Copies of relevant contracts/work order/ work completion Certificate (proving supply of cumulative order value) to be submitted along with bid.
35. Any conditions or qualifications or any other stipulations contained in the Bid shall render the Bid liable to be rejected as a non- responsive Bid .
