

TERMS AND CONDITIONS OF LICENCE

1. The license shall be displayed at a prominent and conspicuous place in a part of the business premises open to the public.
2. The holder of the license shall comply with the provisions of the seed (Control) order, 1983 and the notifications issued there under and for the time being in force.
3. This license comes into force with immediate effect and shall be valid upto 02/11/2020 (2nd November twenty twenty) Unless previously cancelled or suspended.
4. The holder of the license shall from time to time report to the licensing authority and change in the premises where he carries on his business of sale, export, import or storage for the said purposes seeds.
5. The license shall give every facility to the licensing authority or any other officer acting under his authority for the purpose of inspecting his stock in any shop, depot or godown or other place/places used by in him for the purpose of storage. Sale or export of seed.
6. Separate license should be obtain if business is carried more than one place (For each place separately).
