

Department of Finance, Government of Bihar through this communication is announcing the operationalization of the Comprehensive Financial Management System 2.0 (CFMS) effective 07<sup>th</sup> January 2025.


The new application CFMS 2.0 is designed and developed to meet the needs of state government in terms of public financial administration, and improving service delivery. Continuing the legacy of CFMS 1.0, it is ensured that all the processes are made online in a step to reduce the usage of paper-based file movement and encourage the electronic based office operations. Additionally, along with the existing functions of CFMS 1.0, the new application CFMS 2.0 will provide advanced capabilities in terms of process efficiency and direct integrations with other third-party applications, various departmental portals & agency banks to smoothen various processes.

Further, necessary measures & considerations are taken to ensure that existing CFMS 1.0 users can smoothly transition into the new application (CFMS 2.0). In this regard, we request you to kindly take note of the following information:

- To prepare for the transition from CFMS 1.0 to CFMS 2.0, an application downtime of 4-5 days will be required. During this period, the <u>CFMS 1.0</u> <u>application will not be accessible</u> from 03<sup>rd</sup> January' 25 8:00PM onwards until 07<sup>th</sup> January'25 12:00PM.
- Before the schedule downtime from 03<sup>rd</sup> January' 2025, it is required that the DDO offices/ Treasury office completes the following activities:
  - a. HRMS application Prepare and submit the Salary bills in HRMS on or before 03rd January' 2025, 2:00PM. In the event, the salary bills could not

be submitted to treasury before the given time, then the same can be prepared and re-submitted in HRMS after 07th January' 2025, 12:00PM onwards.

- b. CFMS 1.0 application Other contingent bills must be prepared and submitted in CFMS 1.0 on or before 03rd January' 2025 2:00PM. In the event, the bills could not be submitted to treasury before the given time, the bills will be auto cancelled and the same can be prepared and submitted in CFMS 2.0 after 07th January' 2025, 12:00PM onwards.
- c. Treasury Offices The treasury offices are required to process all the received bills (Salary + Contingent etc.) on or before 03rd January 2025, 8:00PM. Any bill which could not be processed in the Treasury will be auto cancelled. The DDO offices will be required to again prepare the cancelled bills in the CFMS 2.0 application/ HRMS application as required.
- 3. The existing OGRAS and e-GPF application will also be replaced with CFMS 2.0. The corresponding functions and portals will be available in the CFMS 2.0 application effective 07th January' 2025.
- 4. Effective 07th January' 2025, the existing CFMS 1.0 users can login into the new application (CFMS 2.0) through the below URLs, using their existing user IDs. The URL for accessing the application is as under:

- 5. Additionally, to guide the user with the usage of the CFMS 2.0 application, module specific User Manuals and Video manuals are being made available in the CFMS 2.0 application and can be accessed upon login.
- 6. Furthermore, all requisite SOPs (Standard Operating Procedures) related to Help-desk operations, new data creation, Migrated Data verification & correction is available in the CFMS 2.0 application for your reference and can be accessed upon login.
