2. For Director (Projects):

- Minimum experience of 15 years in projects and technical side out of which at least 10 years experience should be in the power sector.
- In depth knowledge of project planning and management techniques and experience of managing large projects in a large organization.

III. Other Conditions:

1. For Govt. Department/ PSU Employees:

- The officers working in Central/ State Government and in Central/State PSUs possessing

2. For Private Sector Employees:

IV. Compensation:

- **Pay Scale :** Rs. 37,400-67,000 with Grade Pay Rs.10,000/- (Unrevised) or Pay Level 14 i.e. Rs. 1,44,200/-.
- For Candidate from IAS/Central Services "Group A"/ IES, will Draw the salary payable in their Cadre/parent Organization in this way, the pay given for CMD, MD and whole Time Director of successor Companies of BSEB, in Para-13(a) of the notification, shall not be payable to candidates from IAS/Central Services Group "A"/IES, unless they are eligible for it in their cadre/parent organization.
