The Govt. of Bihar has established a three Member Bihar Electricity Regulatory Commission (BERC) having a Chairperson and two Members. The Commission shall regulate the Electricity industry in the State of Bihar under the provisions laid down in the Electricity Act, 2003. The Selection Committee has been constituted in the terms of the Electricity Act, 2003. The post of Chairman of Bihar Electricity Regulatory Commission (BERC) is vacant.

2. I am directed to invite proposals and nominations of candidates for consideration of the Selection Committee for post of Chairman of the Bihar Electricity Regulatory Commission. The nominees should be persons of ability, integrity and standing having adequate knowledge and experience of, and have shown Capacity in dealing with problems relating to engineering, finance, commerce, economics, law or management.
3. The terms of appointments will be in general accordance with the provisions of The Electricity Act, 2003 and including the following:-
 - (i) The person appointed would have to resign or opt for voluntary retirement from the service to which he/she belongs.
 - (ii) The Chairman would hold office, for a term of five years from the date he enters upon his office, but shall not be eligible for re-appointment in the same capacity in the Commission.

Provided that no Chairman shall hold office as such after he has attained the age of sixty-five years.
 - (iii) Any Chairman in the Commission shall-
 - (a) Not accept any commercial employment for a period of two years from the date he ceases to hold office.
 - (b) Not represent any person before the Central Commission of any State Commission in any manner.
4. The pay of the post of Chairman carries of Rs. 2,25,000/- (Fixed) per month. The allowances payable and the other terms and conditions of service of the Chairman shall be as prescribed by the State Govt. Bihar Electricity Regulatory Commission (Conditions of Services of Chairman and Member) Rules, 2003.
5. The nomination should contain the following:-
 - (i) Bio-data of proposed candidate containing the following details:-
 - (a) Name
 - (b) Age & date of Birth

- (c) Position presently held
- (d) Educational Qualification
- (e) Details of post previously held and experience in the relevant field.

(ii) Willingness letter to resign his/her present post to join Bihar Electricity Regulatory Commission (BERC), if selected.

(iii) A letter from the proposed intimating the details of any office, employment of Consultancy agreement of arrangement with he/she has in his/her own name or in any firm, association of persons of body corporate, or in the name of any relative, carrying of body corporate, or in the names of any relative, carrying on any of the following business, namely:-

- (a) Generation, transmission, distribution or supply of electricity.
- (b) Manufacture, sale or supply of any fuel for generation of electricity.
- (c) Manufacture, sale, lease, hire or otherwise, supply of or dealing in machinery, plant, equipment, apparatus or fitting for the Generation, transmission distribution, supply or use of electricity and,
- (d) Any entity providing professional services to any of the business referred to in clauses (a), (b) and (c) above.

6. The nominations as indicated above are to be sent by speed post/courier to the Principal Secretary, Energy Department, Govt. of Bihar, Vidyut Bhawan-2, Jawahar Lal Nehru Marg, Baily Road, Patna-800001. The nominations may be submitted on or before **30 November, 2023 at 4:00 P.M.**
