In exercise of the powers conferred under the proviso to Article 309 of the Constitution of India, the Bihar Governor is pleased to make the following rules to amend the " Sugarcane Industry Department Non-Gazetted Cadre (Recruitment and Service Conditions) Rules, 2016."

1. Short Title, extent and commencement - (i) These rules may be called " The Sugarcane Industries Department Non-Gazetted Cadre (Recruitment and Service Conditions) Rules 2024 ".

(ii) It shall extend to the whole of the State of Bihar.

(iii) It shall come into force at once.

2. Amendment of Rule 9 of The Sugarcane Industries Department Non-Gazetted Cadre (Recruitment and Service Conditions) Rules, 2016. Rule 9 of the said rules is amended as follows :-

" 9. Confirmation. - The service of directly recruited personnel may be confirmed after satisfactory completion of the probation period, passing the Hindi Noting and Drafting Examination and Computer Competency Test, completing the prescribed training and passing the departmental examination as prescribed."
