# Registration for Sale & Manufacture of fertilizer/fertilizer mixture/Bio fertilizer/Organic Manures

1. Issue of Letter of authorisation for sale of fertilizers: Form A2 is issued by Director of Agriculture and District Agriculture Officers. Director of Agriculture issues A2 for wholesale to manufacturers/suppliers/importers/pool handling agencies or apex cooperative societies of Central and State Governments. The A2 issued by Director of Agriculture is valid for whole state. Other categories of business organizations/persons/agencies may seek letter of authorisation of sale of fertilizer from respective District Agriculture officer where fertilizer business is to be carried out. District Agriculture Officer is empowered to issue A2 for wholesale as well as retail for their area of jurisdiction.

## 2. Fee and Documents required for obtaining A2(sale permission) for wholesale for the whole State:-

- 1. Two copies of form A1 (original) along with fee of Rs. 2250.00 deposited through Treasury Challan.
- 2. Three recent PP size photos of the applicant duly signed and name of the applicant written on them.
- 3. Letter of authorisation from competent person of the firm for which sale authorisation is to be obtained.
- 4. Form O (Not required for manufacturers/importers)
- 5. Photocopy of letter of authorisation(A2) of the Form O issuing firm duly attested.
- 6. An affidivt containing following declarations:-
- (a) The applicant has not been convicted for an offence under FCO-1985 or ECA within 3 years from the date of application.
- (b) Authorisation letter of the applicant is not under suspension.
- (c) Authorisation letter of the applicant has not been cancelled in any state within one year from the date of application.
- 7. Attested copy of Memorandum of Association or proprietorship deed.
- 8. Copy of Form F (For sale permission of Mixture of fertilizers/Micronutrient Mixture/Bio-fertilizers/Organic manure).
- 9. Attested copy of Registration letter from Industry department.
- 10. Attested copy of letter of authorisation (A2) issued by the state govt. where applicant firm is situated.
- 11. No objection Certificate from local Sale Tax Circle office.
- 12. Appointment letter of responsible person under Cl. 24 of FCO.
- 13 Attested copy of letter of Agreement for office space and godown.
- 14. For Importers :-

- (a) Attested copy of Import Export Certificate issued by GOI.
- (b) Certificate of origin.
- (c) Copy of Supply order.
- (d) Copy of Certificate of Analysis.

#### 15. For Bio-fertilizers/Organic Manures :-

- (a) Attested copy of Form F issued after 3.11.2009.
- (b) Production Capacity in tonnes.
- (c) Copy of Analysis Report issued by Quality Control Laboratory notified by Govt. of India.

#### (B) Renewal of letter of authorisation

Apply before date of expiry of the period of validity of authorisation letter along with documents and fee mentioned in Sl. no. 2 above and sale report of the preceding year and copy of challan of a VAT payment However one can apply for renewal with additional late fee of Rs. 75/- within one month from date of expiry of the validity of the A2 (authorisation letter) issued.

- (e) <u>Amendment</u>: An application for amendment along with fee of Rs. 150/- and required document are to be submitted to Director of Agriculture.
- 3. Certificate of Manufacture of Mixture of Fertilizers/Micronutrient mixtures/Bio-fertilisers/Organic Manures: Application is to be submitted to Director of Agriculture along with prescribed fee and documents required.

#### A. Documents required to obtain Certificate of Manufacture.

- 1. Two copies of form D along with fee of Rs. 1000.00 deposited through Treasury challan.
- 2. Three recent PP size photos of the applicant duly signed and name of the applicant written on them.
- 3. Letter of authorisation from competent person of the firm for which Certificate of Manufacture is to be obtained.
- 4. An affidivt containing following declarations:-
- (a) The applicant has not been convicted for an offence under FCO-1985 or ECA within 3 years from the date of application.
- (b) Registration of the applicant is not under suspension.
- (c) Registration of the applicant has not been cancelled in any state within one year from the date of application.
- 5. Attested copy of Memorandum of Association or proprietorship deed.
- 6. Oath regarding availability of Minimum Laboratory Facility according to standard prescribed under Clame 21A of FCO.

- 7. Declaration that applicant has qualification of B. Sc. (Ag) or B. Sc. (Chemistry) Hons. as prescribed by the State govt. under clause 14(1) of FCO or has appointed a person having such qualification.
- 8. No objection Certificate from local Sale Tax Circle office.
- 9. Appointment letter of responsible person under Cl. 24 of FCO.
- 10. Attested copy of Registration letter from Industry department.
- 11. Copy of NOC from Pollution Board.
- 12. Copy of lease agreement/deed of space used for this purpose.
- 13. Attested copies of Bill for purchase of Lab requirments.
- 14. Attested copy of letter of appointment of chemist with qualification certificate.
- 15. **For Bio-fertilizers/Organic fertilizers :**Declaration that production capacity is 50 mt or above
- B. **Renewal of COM**: COM can be renewed subject to the satisfaction of Director of Agriculture-cum-Registering Authority as specified in clause 18(2) of FCO. Apply for renewal before the date of expiry of COM. However application for renewal can be made within one month from the date of expiry of the validity of certificate of manufacture issued with a late fee of Rs. 100/-.

Apply with fee and documents mentioned in 3A. Beside that following documents are to be submitted for renewal.

- (i) 18" x 4" size photo showing information written of packet/bag.
- (ii) Sale report of the preceding year.
- (iii) Copy of challan of VAT payment.

Note: All Photocopies must be attested by notary or Gazatted officer.

- 2. The holder of this certificate shall not keep in the premises in which he carries on the business of making the physical/granulated mixture/bio-fertiliser/organic fertiliser in respect of which a certificate of registration has bot been obtained under the Fertiliser (Control) Order, 1985.
- 3. Holder of this certificate shall comply with the provisions of the Fertiliser (Control) Order, 1985 and the notification, order and direction, issued therunder for the time being in force.
- 4. The holder of this certificate shall report forthwith to the Registering Authority any change in the premises specified in the certificate or any new premises in which he carried on the business of making physical/granulated mixture/organic fertiliser/bio-fertiliser and shall produce before the authority the original certificate and copies thereof so that necessary corrections may be made therein by that authority.
- 5. The holder of this certificate shall ensure that the physical/granulated mixture/organic fertiliser/bio-fertiliser in respect of which a certificate of registration has been obtained is prepared by him or by a person having such qualifications, as may be prescribed by the State Government, from time to time or by any other person under the direction, supervision and control of the holder or the person having the said qualifications.
- 6. The certificate and copies thereof, if any, will be machine numbered and delivered against the signature of the holder thereof or his agent on the carbon copy of the certificate which will be kept intact bound in the Certificate Book by each Registering Authority.
