1. Bid Validity Period

The Bid Validity Period will be End of Sonepur Mela, 2025.

2. Earnest Money Deposit (EMD)

Refundable Earnest Money shall be deposited as indicated in the "Notice Inviting Tender" failing which the Bids submitted the agency shall be out-rightly rejected.

- 2.1 No interest will be payable on the amount of EMD irrespective of the outcome of tendering process.
- 2.2 The EMD of unsuccessful bidder will be returned after expiry of Bid validity period or issue of Letter of Award (LOA) and submission of performance guarantee by successful bidder, whichever is earlier.

3. Performance Guarantee (Non-Interest bearing)

- 3.1 The successful bidder has to submit performance guarantee (PG) of Rs. 1,00,000/- (One Lakh only) in the in the form of a Demand Draft drawn form a Schedule Bank/Nationalized Bank in favour of "Under Secretary-CUM-DDO, Revenue & Land Reforms Department, Bihar, Patna" payable at Patna failing which the EMD shall be forfeited.

6. Bid Price and Evaluation of Financial Bid and Letter of Award (LOA)

- 6.1 All taxes and other charges like transportation etc. shall be included in the Quoted Rates and shall be written in the blank space specified on APPENDIX-I. However, in the Invoice, Tax (es) has to be shown separately.
- 6.2 No advance payment will be made.
- 6.3 The price should be quoted in both in words and figures and in Indian Rupees only.
- 6.4 Taxes will be deducted at source as applicable.
- 6.5 The bidder shall quote for all of the items as mentioned under Financial Bid. L-1 bidder will be evaluated on the basis of total cost then will be selected.
- 6.6 Revenue & Land Reforms Department, Bihar, Patna will issue Letter of Award (LOA) to the successful bidder.

6.7 Work orders will be issued upon requirement only. Selection of bidder under the RFQ or Issuance of LOA will not guarantee issuance of work order/s and Revenue & Land Reforms Department, Bihar, Patna will not assume any liability or cost towards it.

6.8 Items will have to be supplied as per the quantity and specification mentioned in the work order. The quality of the items supplied should be as per satisfaction of Revenue & Land Reforms Department, Bihar, Patna. The supplies have to be made at the site of Sonepur Mela.

Failure on the part of successful bidder to do so may result in cancellation of its LOA/Work Order and their Performance Guarantee may be forfeited.—In such case, Revenue & Land Reforms Department, Bihar, Patna may, at its liberty, negotiate with other bidders (L-2 and so on) for the supplies to be made at L1 prices or at negotiated rates. Also in case of exigencies and volume of supplies, Revenue & Land Reforms Department, Bihar, Patna may request L2 bidder of respective items and so on to make the supplies at the negotiated rate of L-1 bidder.

- 6.9 The rate quoted shall be valid for Sonepur Mela, 2025 from the date of issuing of LOA.
- 6.10 Payment shall be released on submission of bills with copy of work order issued by Revenue & Land Reforms Department, Bihar, Patna. The satisfactory performance will be the essence under this contract and would need to be executed in the specified time frame and quality as per the work order. If the work of the tenderer is not satisfactory then payment will be made in the light of the recommendations of the committee constituted at the authority level. Revenue & Land Reforms Department, Bihar, Patna may at its discretion be able to reject whole of the supplies, if they were found to be of unsatisfactory quality. In that case, fresh supplies will have to be made at the bidder's own cost. The decision of Secretary, Revenue & Land Reforms Department, Bihar, Patna will be final and conclusive in this regard. Revenue & Land Reforms Department, Bihar, Patna reserves the right to get work done as this risk of cost the approved vendor.
- 6.11 The continuous unsatisfactory performance may lead to confiscation of performance guarantee and cancellation of LOA. The decision of Secretary, Revenue & Land Reforms Department, Bihar, Patna will be final and conclusive in this regard.
