4- तालिका में अंकित विभिन्न मानकों के सिरिज-निडल तथा निडल में से अपने जिला के लिए आवश्यकतानुसार सिरिज-निडल तथा निडल का क्रय चयनित आपूर्तिकर्ता/दर के आलोक में किया जाये। सिरिज-निडल तथा निडल के क्रय क्रम में संगत **निविदा की शर्तों एवं एकरारनामा की शर्तों** का पूर्णतः अनुपालन सुनिश्चित किया जाये। तदालोक में **आपूर्ति आदेश, एकरारनामा एवं निविदा शर्तों के आलोक** में भुगतान की कार्रवाई की जाये।

5- उपलब्ध आवंटन के आधार पर आवश्यकतानुसार समानुपातिक रूप से सिरिज-निडल तथा निडल का क्रयादेश दिया जाये। सभी जिला पशुपालन पदाधिकारी, बिहार संबंधित आपूर्तिकर्ता को क्रयादेश देने के साथ ही सम्पादित एकरारनामा के आलोक में आपूर्तिकर्ता को विभिन्न मानकों के सिरिज-निडल तथा निडल आपूर्ति हेतु अधिकतम 28 (अट्ठाईस) दिनों का समय देना सुनिश्चित किया जाये।



AGREEMENT

This agreement was executed between the Authorized Representative of the supplier firm M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113 Mr. Rahul Sharma, General Manager and the representative of Animal and Fisheries Resources Department, Bihar- Dr. Sunil Kumar Thakur, Joint Director (AH), Animal Husbandry Directorate, Bihar on 31.07.2025 at 3:00 PM.

1. That in the meeting of the Purchase Committee held on 15-07-2025 (Proceedings of the meeting issued vide memo no. 2522 (Ni) dated-15-07-2025), with regards to tender notice no. PR - 003212 (Animal) 25-26 & Notice inviting Tender Ref. no.: 2025/AHD/05, the rate quoted by M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113 for Syringes-Needles and Needles as mentioned overleaf were found to be the lowest (L₁) for two years from the date of agreement or till finalization of next tender. The GST will be applicable in addition to the Basic Rate (including other expenses) quoted by the L₁ firm.

2. That the Supply order of Syringes-Needles and Needles mentioned under paragraph 1 will be given by the Director, Animal Husbandry, Bihar/Director, Institute of Animal Health & Production, Bihar, Patna /Project Director, BLDA, Patna/Regional Director, Bihar/concerned District Animal Husbandry Officer to M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113.

3. This agreement is valid for supply of Syringes-Needles and Needles mentioned under paragraph 1 for two years from the date of agreement i.e, dated-30-07-2027.
 4. That M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113. has to furnish the performance security deposit of Rupees 12.50 Lakh (50 percent of the general security amount 5% i.e, @2.5%) for Syringes-Needles and Needles mentioned under paragraph 1 in the form of Bank Guarantee (BG) of any commercial bank in favour of the Director, Animal Husbandry, Bihar, Patna and payable at Patna only. M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113 shall timely revalidate the BG furnished as Performance Security Deposit (If required).
 5. That the Performance Security Deposit will be released & returned back to M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113 after successful supply of the ordered goods as per terms and condition of tender or agreement or work order. The Performance Security Deposit shall be forfeited in case M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113 fails to supply the goods in requisite quantity within 28 days of the supply order or within stipulated time or fails to comply with any of the terms & conditions of the tender/supply order/agreement or the Syringes-Needles and Needles supplied are found to be of sub-standard quality by the competent authority.
 6. That M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113 will have to supply the Syringes-Needles and Needles as per the supply order to the office of the Director, Institute of Animal Health and Production, Patna/Project Director, BLDA, Patna/Regional Director, Bihar/concerned District Animal Husbandry Officer, in accordance with the conditions mentioned in the Tender Notice, Agreement and Supply Order.
 7. That the Syringes-Needles and Needles will be received as per rules by the office of the Director, Institute of Animal Health and Production, Patna/Project Director, BLDA, Patna/Regional Director, Bihar/concerned District Animal Husbandry Officer or his/her authorized representative after performing all checks, proper satisfaction and verification as per clause 8 below.
 8. That the Syringes-Needles and Needles are to be supplied as per the terms and conditions mentioned in the tender notice no. PR No. 003212 (Animal) 25-06 & Notice inviting Tender Ref. no.: 2025/AHD/05.
 9. That no supply will be accepted after the due date as mentioned in supply order, unless and until specific order is issued by the Director, Animal Husbandry, Bihar. In the event of the supply not made in full quantity on or before the due date M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113 will be levied penalty @3% of the total value of delayed supply and it may be blacklisted as per standard norms and procedure.

10. That the technical specifications of the supplied Syringes-Needles and Needles must be in accordance with that mentioned in the tender notice otherwise the supply will not be accepted. Any deviation in the technical specifications of the supplied Syringes-Needles and Needles will not be acceptable, and it will be the sole responsibility of M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113.
11. That all the packaging should be primary (New). M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113 shall provide such packaging of goods as is required to prevent their damage or deterioration during transit to their final destination. The packaging should be sufficient to withstand without limitation rough handling during transit & open storage.
12. That all the supplies should invariably display the particulars on its label and/or carton in a distinct manner.
13. The manufacturing date, batch no., Expiry date etc. must be disclosed on the body of the packages. The supplied Syringes-Needles and Needles should be labelled as **"For Government of Bihar use-Not for sale"**.
14. That the expiry date should be mentioned on the body of the Syringes-Needles and Needles pack and body of the bills. The expiry period should be a **minimum of 24 (Twenty four) months** from the date of supply, which may be reduced by the competent authority of the department as and when required on the basis of the field situations and requirement for utilization. The deviation if any in this regard must be approved before by the Director, Animal Husbandry. Any violation/deviation without approval of competent authority would lead to violation of terms and conditions of the agreement.
15. That the copy of quality test report of each batch of the Syringes-Needles and Needles being supplied must be submitted to the Director, Institute of Animal Health and Production, Patna/Project Director, BLDA, Patna/concerned Regional Director, Bihar/concerned District Animal Husbandry Officer along with supply.
16. That the Animal and Fisheries Resources Department, Bihar will not be held responsible for any loss/damage during the transportation of the Syringes-Needles and Needles. Only the Syringes-Needles and Needles properly supplied as per the agreement/supply order and in perfect condition will be accepted.
17. That the delivery challan in triplicate must be submitted along with the consignment. One copy of the challan should be submitted to the office of the concerned District Animal Husbandry Officer, the second copy should be submitted to the office of the Director, Institute of Animal Health & Production, Bihar, Patna and the third copy should be retained by M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113 (for supply order of mass vaccination programmes).

18. That M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113 has to generate invoices separately for each district and for each component (General/SC/ST SP) and obtain a certificate from concerned District Animal Husbandry Officers on the invoices (vouchers) of the supplied vaccine as mentioned below (for supply order of mass vaccination programmes):

19. If any adverse report on any Needle and Syringe is received and proved, the Supplier / bidder will have to refund the entire cost of Needles and Syringes supplied along with forfeiture of EMD/SD. In case where payment is not required to be released the same shall be forfeited to Govt. Besides the above, action will be initiated for black listing M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113 on the report of the competent authority.
20. That the payment against all the accepted and valid supplies as per terms and conditions of agreement and supply order will be made by the concerned authority who has placed the order i.e, Director, Animal Husbandry, Bihar/Director, Institute of Animal Health & Production, Bihar, Patna /Project Director, BLDA, Patna/District Animal Husbandry Officer after due diligence and as per Bihar Treasury Code and Bihar Financial Rules among others.
21. That no payment will be made before complete items have been supplied as per supply order and as per terms and conditions of supply order and agreement. Payment will be made as per clause 20 above and at the approved final offered price with applicable taxes and no other charges will be admissible. The TDS will be deducted at sources as per the prevailing norms in this regard.
22. That if at any time during the period of contract, the price of any tendered item is reduced or brought down by any law or act of the Central or State Government or M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113, M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113 shall be morally and statutorily bound to inform the Director, Animal Husbandry, Bihar immediately about such reduction in the contract price. The Director, Animal Husbandry, Bihar is empowered to unilaterally effect such reduction as is necessary in rate, in case the bidder fails to notify or fails to agree for such reduction of rate.
23. That M/s Saksham Life, Vishunpur Govind, Karja Marwan, Muzaffarpur-843113 has to inform the Directorate of Animal Husbandry, Bihar and Institute of Animal Health & Production, Bihar regarding the supply

schedule of the Syringes-Needles and Needles along with its batch no. and other necessary information (for supply order of mass vaccination programmes).

24. That if any dispute arises at any time between the two parties in respect of or concerning anything herein contained or arising out of the agreement or as to the rights, liabilities or duties of supplier and the Director, Animal Husbandry, Bihar, Patna, the same shall be referred to the sole Arbitrator, the Additional Chief Secretary/Principal Secretary/Secretary, Department of Animal & Fisheries Resources, Bihar, Patna. The decision of the Arbitrator shall be final and binding on all the parties. The venue of the arbitration shall be at Patna, (Bihar, India). The arbitrator will give reasoned decision.

25. That any legal dispute is subject to competent court of Judicature at Patna only.
