In exercise of the powers conferred under provision to the Article 309 of the Constitution of India, the Governor of Bihar is here by pleased to make the following rule to amend "The Bihar Animal and Fisheries Resources (Fisheries) Service Recruitment Rules 2007 (as amended from time to time)" -

1. Short Title, Extent, and Commencement –

- (1) These rules shall be called the "The Bihar Animal and Fisheries Resources (Fisheries) Service Recruitment (Amendment) Rules, 2025. "
- (2) It shall extend to the whole of the State of Bihar.
- (3) It Shall come into force from the date of its publication in the official Gazette.

2. Substitution of Rule-6 of the "Bihar Animal and Fisheries Resources (Fisheries) Service Recruitment Rules, 2007– Rule 6 of the aforesaid rules shall be substituted as follows:

Under the 'Bihar Animal and Fisheries Resources (Fisheries) Service Cadre Rules, 2007 (as amended from time to time),' for the selection of candidates for specified posts through direct recruitment, marks shall be awarded for competitive examination and work experience. The syllabus for the competitive examination has been prescribed by Animal and Fisheries Resources Department (Fisheries) Notification No. 1432 dated 01.10.2012. The total marks for the competitive examination and work experience shall be 100. The distribution of these 100 marks shall be as follows:

| (i) Consideration for the marks obtained in the competitive examination | – 75 marks |
| (ii) Weightage of a maximum of 25 marks will be given for the period of satisfactory work done only in same post on contract basis in the Government of Bihar or in a non-private institution located within the state of Bihar (Central Government, Panchayat, Municipal body etc.) | – 25 marks |

Total Marks – 100 marks

Note: (i) (a) The marks to be awarded to a candidate for the marks obtained in a competitive examination will be determined by multiplying the percentage of the total marks obtained in the said competitive examination by a multiple of factor of 0.75. For example, if a candidate has obtained 60 percent marks in the competitive examination, then he will be given $60 \times 0.75 = 45$ marks .

Note: (i) (b) The minimum qualifying marks for the competitive examination will be **30 Percent**.

3. **Substitution of Rule-10 in the Bihar Animal and Fisheries Resources (Fisheries) Service Recruitment Rules, 2007** Rule 10 of the said Rules shall be substituted by the following :-

10. (a) Departmental Examination:-

- (i) Government servants appointed on direct gratuity shall have to pass the departmental examination as prescribed by the Central Examination Committee, Board of Revenue.
- (ii) The subject, syllabus and procedure of the Departmental Examination shall be determined by the Board of Revenue in consultation with the Governing Department.
- (iii) The first annual increment to the newly appointed Government servants shall be admissible after passing the Hindi Note and Drafting Examination conducted by the Directorate of Official Language and the next annual increment after passing the Departmental Examination as prescribed.

(b) Confirmation : -

Service will be confirmed after satisfactory completion of probation period, successful completion of training and passing of departmental examination.

4. **In the Bihar Animal and Fisheries Resources (Fisheries) Service Recruitment Rules, 2007, the process of recruitment to the posts notified in column (2) of serial no. 5 of Appendix-I of Rule-6 shall be amended to the extent that: -**

Appointment in the category of Fisheries Extension Officer / Junior Fisheries Research Officer / Junior Lecturer -

- (i) 75% of the posts of Fisheries Extension Officer Cadre shall be filled by direct recruitment on the basis of the results of the competitive examination and work experience conducted by the Bihar Technical Service Selection Commission from time to time for the purpose.
- (ii) The remaining 25% of the posts will be filled by the promotion of the Fisheries Development Officer Cadre. Such promotion shall be made on the basis of recommendation of the Departmental Promotion Committee constituted for the said purpose.
