In the above purchase, preference will be given to the local enterprise in the light of Bihar Purchase Preference Policy, 2024 issued via Financial Department ref No. 8550 Dated-07.08.2024/ on the basis of requisition and documents submitted by them.

#### 2. Terms and Conditions

- A. The contract would be valid for one year from the date of contract and can be extended for further two years based on the performance on similar term and condition at the sole discretion of the State Commissioner Disability, Bihar, Patna.
- B. The selected agency shall be responsible to provide the same model additional vehicle/s as mentioned in Schedule-I & Schedule-II at the same rate on the basis of as and when needed.

- C. The vehicle provided must be commercial registered in Bihar and properly insured.
- D. Vehicle model should not be of earlier than 2023. All vehicles should be with A.C.
- E. The Driver must have the licenses and properly dressed up with Khaki or white Shirt & Trousers during the duty hours.
- F. The Agencies will be solely responsible for any misconduct of the drivers.
- G. No advance payment would be made
- H. TDS as applicable will be deducted at source from bill/s as per the Income Tax Act & GST Act.
- Office of the State Commissioner Disability, Bihar, Patna reserves the right to terminate the contract with 30 days' notice without assigning any reason.
- J. In case of any Loss, damage or accident, total responsibility lies with agency, it will be fully responsible in case unauthorized / illegal materials are found in the vehicle during the use of the officials of the State Commissioner Disability, Bihar, Patna.
- K. Parking & toll taxes will be reimbursable on actual.
- L. The Payment will be made on monthly and daily basis and shall be made preferably within 15 days following submission of invoices duplicate by the Agency supported by log book.
- M. The Vehicle should be in good condition with <u>High Security Registration Plates (HSRP)</u> and should be provided on time. Replacement of vehicle shall be done immediately in case of repair, maintenance or any other condition with equally good condition vehicle.
- N. The agency shall be responsible for appropriate insurance coverage of Vehicle. In this regard, the agency shall maintain Driver's compensation; Agency shall also maintain comprehensive general liability insurance, including contractual liability coverage adequate to cover the indemnity of obligation against all damage to any property arising out of, or in connection with, the services which result from the fault of the agency, or its driver. The Agency shall provide office of the State Commissioner Disability, Bihar, Patna with certification thereof upon request.
- O. The Agency should have enough resources to repair their vehicles in minimum possible time. When required, they should be in a position to substitute/replace or arrange extra vehicle at very short notice.
- P. The Agency shall not employ any person as driver who has not completed 18 years of age. The agency shall comply with all statutory provisions as laid down under various Labour Laws like Minimum wages, Contract Labour Act etc. In case of violation of any such statutory provisions, the agency will be solely responsible.
- Q. In case of failure to provide vehicle on time, SCD will hire a vehicle from open market and the charges paid to such vehicle will be deducted from the monthly bill of the Agency. In addition, a penalty of Rs. 2,000/- per day, maximum up to Rs. 10,000/- for the month till the date of default shall also be charged by the SCD from the Agency, which will be deducted from the bill.
- R. The Agency shall be solely liable for any legal issues.
- S. The Agency chosen as L1 shall deposit Performance Security as mentioned in the Bid document only within 7 days from the issue of LOI. It should be submitted in the mode of DD / Bank Guarantee in favor of office of the State Commissioner Disability, Bihar, Patna. The contract shall be signed only after furnishing of performance security. In case of breach of contract by the contractor, the performance security shall be forfeited by the office of the State Commissioner Disability, Bihar, Patna and the Agency shall be blacklisted in addition to the termination of the



contract.

- T. The Agency shall submit attested copies of owner book, insurance papers and other papers of the vehicle and attested copies of driving license of the Driver.
- 3. Additional Terms and Conditions for Monthly Hired Vehicle: In addition to terms and conditions mentioned above in para-2, the following additional terms and conditions shall be applicable on vehicles taken on monthly and daily basis: -
  - 1. Driver shall be provided with mobile phone for smooth communication.
  - 11. The duty timing of the monthly hired driver would be normally from 8 am to 8 pm but could be longer as per requirement and need.
  - III. The agency will have to provide the replacement of driver in case of any eventuality. Office of the State Commissioner Disability, Bihar, Patna has the right to ask the agency for removal of any Driver, who is not found competent or disciplined.
  - IV. Once assigned, the vehicle will not be changed/ replaced without prior permission of the State Commissioner Disability, Bihar, Patna.
  - v. There shall be separate log book for monthly vehicle maintained by the driver/agency. All entries in the log book will be verified/ countersigned by the concerned officers in the respective log book of the vehicle.
  - VI. The firm whose contract has been terminated or whose services has been found to be dissatisfactory and decision has been taken to discontinuation the services that firm cannot participate in this tender.

#### 4. Bidding Process, Evaluation of bids and Contract:-

- 1) The Bid process will be done through E-procurement process. The technical bid would be opened and evaluated firstly. Financial bids of only those bidders who qualify in technical bid would be opened for evaluation. Technical bid should contain all the documents and testimonials as given in the eligibility condition.
- 2) In case of unsatisfactory service by selected agency or cancellation of contract within the contract period, office of the State Commissioner Disability, Bihar, Patna can obtain service from any other bidders at L1 prices of each vehicle.
- 3) The successful bidders will enter into contract with office of the State Commissioner Disability. Bihar, Patna as per above terms and conditions within 15 days of finalization of the bidding process. Failure on the part of bidder to do so may result in cancellation of its bids and office of the State Commissioner Disability, Bihar, Patna may at its liberty to negotiate with other bidders for the contract at L1 prices.
