## **Tender Notice**

Sealed tender under TWO BID SYSTEM is hereby invited by the Govt. of Bihar from manufacturers or DGCA's approved firms/ Companies/ Public enterprises for Purchase of Spares and Consumables (as per annex.-I) for King Air C-90 A/B VT-EBG Aircraft as per the following terms and conditions: -

- 1. Bid submission starts from 16.09.2025 Tender Schedule has been provided in Sl. No 13 of this Notice.
- 2. The tender must reach to Director, Directorate of Aviation, Patna, Airport on or before 13.10.2025 at 05:00 PM. by registered post/speed post/courier or by hand only.
- 3. Bidders shall submit their offer in two separate sealed envelopes one as Technical Bid and other as Financial Bid. The type of Bid must be written on each envelope (Technical/ Financial Bid). These two bids shall be kept in another big envelope which should be sealed and subscribed as "Tender for supply of Spares and Consumables for King Air C-90 A/B VT-EBG."
- 4. Along with physical submission of bids, bidders must also submit the 'Technical Bid' online through email, with the subject line as "Technical Bid for the supply of Spares and Consumables for King Air C-90 A/B VT-EBG" on the Email-ID: <a href="mailto:cadbihar@bihar.gov.in">cadbihar@bihar.gov.in</a> on or before 13.10.2025 at 03:00 PM. Please number the documents with serial number on each and every page and do mention the total number of pages of bidding document.

### 5. Technical Bid should contain the following:

- A. An undertaking in the form of affidavit on 100 Rupees stamp paper that the Company has not been blacklisted by any Public Sector undertaking/ Government Organization/ DGCA.
- **B.** An EMD of Rs 50,000.00 (Rs fifty thousand only) in the form of Bank Draft issued by a Scheduled/ Nationalized Bank in India, drawn in favour of Bihar Flying Inst. C.A Department, Cabinet Secretariat Department, Patna.
- C. Self-attested copies of GST registration and PAN details.
- D. Income Tax return certificate for Preceding three Assessment years of the bidder.
- E. Lead Time for supply of spares should be mentioned.

#### 6. Financial Bid should contain the following:

- **A.** Rate of outright new spares/new spares with core exchange. Rate should be quoted in Indian Rupees (₹) only and should be firm and fixed inclusive of all taxes.
- **B.** In case of non-availability of the new Spares, then bidder shall quote the rate of overhauled spares/overhauled spares with core exchange.
- C. The quoted rate shall be for door delivery to the **Directorate of Aviation**, **State Hangar**, **Patna**, **Bihar**, inclusive of all taxes, with no additional charges applicable or payable.
- D. Financial bid shall clearly specify delivery schedule and payment terms.
- E. Financial bid shall specify the validity of quoted rates for a period of 120 days from the last date fixed for submission of tenders.
- F. Financial bid shall specify the Warranty/ Guarantee details.
- G. Evaluation of financial bid will be done on the basis of the quoted rate. Financial bid will be opened only of those bidders whose technical bid are found to be responsive and meet all specified requirements.
- 7. Each part in the bidding process will be considered as a separate unit. Therefore, bunching of parts is not allowed.
- 8. Security money of Unsuccessful bidders will be refunded immediately after final selection.



- 9. Spare parts supplied by company must have up to date serviceable tag/ FAA tag. The items received with old serviceable tag/FAA tag will not be accepted and returned back to the company at their own cost. The items not meeting above mentioned requirement will be returned back to the supplier at their
- 10. The Technical bid of the tender will be opened tentatively on 15.10.2025 at 3.30 PM before the committee headed by Additional Chief Secretary, Cabinet Secretariat Department, Bihar, Patna or by an officer so authorized by him before bidders/ authorized representatives.
- 11. The date & time of opening of the Financial bid of the tender (only for Technically responsive bids) will be announced later and can be seen on departmental website <a href="http://state.bihar.gov.in/csd">http://state.bihar.gov.in/csd</a>
- 12. Correction of Errors: "Financial Bids" determined to be substantially responsive will be checked by the buyer for any arithmetic errors. Errors will be corrected by the buyer as follows:
  - a. where there is a discrepancy between the rates in figures and in words, the rate in words will govern; and
  - b. where there is a discrepancy between the unit rate and the line-item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern.

The amount stated in the "Financial Bid" will be corrected by the buyer in accordance with the above procedure and the bid amount adjusted with the concurrence of the Bidder in the following

- a. If the Bid price increases as a result of these corrections, the amount as stated in the bid will be the 'bid price' and the increase will be treated as rebate.
- b. If the bid price decreases as a result of the corrections, the decreased amount will be treated as the 'bid price.'

Such adjusted bid price shall be considered as binding upon the Bidder. If the Bidder does not accept the corrected amount the Bid will be rejected, and the Earnest money may be forfeited.
