- 5. Bid Validity Period The Bid validity period will be 180 days.
- 6. Joint venture/consortium/subletting in any form will not be allowed.
- 7. The bidder must be Original Equipment Manufacturer (OEM) / Reseller having legal entity registered with a valid Certificate of Registration under the applicable laws.
- 8. The Manufacturer's Authorization Certificate is mandatory for any Bidder other than the OEM. In case a Reseller submits a bid with OEM authorization, the same OEM shall not be permitted to participate separately in the bidding process. If both the Reseller and the OEM apply in the same bid, the participation of both shall be summarily rejected.
- 9. The Bidders are requested to register on the e-procurement process. The bidder shall get themselves registered with service provider (BELTRON, Bihar) so that User ID, Password and Digital Signature are issued to them. This will enable them to access the website https://eproc2.bihar.gov.in and download/participate in e-tender.

- 11. E-Tender can be downloaded or uploaded only on website https://eproc2.bihar.gov.in.
- 12. The e-Procurement portal (https://eproc2.bihar.gov.in) will not accept any bid after the last date and time prescribed for submission of bids. The ICDS Directorate shall not accept any hard copy of the bid, nor shall it entertain any request for consideration of bids submitted after the deadline on account of technical problems or any other reason. Bidders are, therefore, advised to submit their bids well in advance to avoid last-minute contingencies.
- 13. The Bidders shall submit their eligibility and qualification details for the Bid in the online standard formats displayed in e-Procurement website. The Bidders shall upload the scanned copies of all the relevant certificates, documents etc., in support of their eligibility criteria/technical bids and other certificates /documents on the e-Procurement website.

- 14. The Bidder shall sign on every statement, documents, certificates, uploaded/attached by him/her, owning responsibility for their correctness/authenticity.
- 15. Bid Processing Fee, Cost of Tender document and Earnest Money Deposit (EMD) has to be paid as mentioned in the tender document.
- 16. The Bidder shall deposit an EMD/Bid Security of approx 2 % of Estimated Bid Value (EBV) in accordance with the terms of this BID. The Bidder has to pay the EMD/Bid Security of Rs. 40,00,000/- (Rupees Fourty Lakh Only) through online mode or in the form of Demand Draft/ Unconditional Bank Guarantee (B.G) in prescribed format as per tender document issued from a Nationalized/Schedule Bank. Validity of Demand Draft/Bank Guarantee shall be 225 days from last date of Bid submission. A scanned copy of the Demand Draft / Bank Guarantee must be uploaded on the portal with technical bid and the original hard copy of Demand Draft / Bank Guarantee must be submitted before opening of technical bid.
- 17. Micro, Small & Medium Enterprises (MSME), Small Scale Industries (SSI), and Start-up Companies are exempted from payment of EMD, provided they submit a valid MSME/NSIC/DIPP certificate along with their bid.
- 18. Local Manufactures as per Bihar Purchase Preference Policy 2024 are exempted from EMD / Cost of Tender document.
- 19. Offers submitted without Earnest Money Deposit (EMD) or a valid EMD exemption certificate shall be rejected.
- 20. The Supplier shall warrant that the Smart TV(s) supplied under this Contract shall be free from all defects in material, workmanship, design and shall conform to the specifications mentioned in Section-1 of tender document This warranty shall remain valid for a period of Thirty-Six (36) months from the date the supply or any portion thereof as applicable.
- 21. Specification of the 43-Inch Commercial Smart LED TV and eligibility and qualification requirements of the Bidder (OEM/RESELLER) can be seen in the tender document.
- 22. The bidder (OEM/Reseller) should make sure the download ability/visibility of uploaded scan document.
- 23. Bihar Purchase Preference Policy, 2024 will be applicable on this bid.
- 24. No Bidder shall be permitted to submit more than one Bid for the same work/same NIT number.
- 25. Any Addendum or Corrigendum issued shall be in writing and attached/uploaded on the e-procurement platform (https://eproc2.bihar.gov.in), forming an integral part of the Tender Document. Bidders are required to monitor the e-Procurement portal regularly to track any

- Addenda/Corrigenda issued by the Tender Inviting Authority. The Tender Inviting Authority shall not be responsible for any claims or issues arising from a bidder's failure to do so.
- 26. The Bidder shall submit one sealed sample of 43-Inch Commercial Smart LED TV as per specification mentioned in the tender document before Bid end date at the office of the ICDS Directorate, Bihar, Patna.
- 27. The Purchaser reserves the right to increase or decrease the quantity of items to be ordered by up to 20% at the time of placement of the final contract. The Bidders (OEMs/Resellers) shall be bound to accept and execute the order accordingly.
- 28. The product shall be supplied to CDPO offices across the State of Bihar within two months (60 days) from the date of issuance of the supply order. The quoted cost of goods shall be inclusive of all applicable Taxes, Duties, Samples, Testing, Installation & Commissioning, Transportation charges etc. and any other incidental expenses.
- 29. The Bid Processing Fee and the Cost of Tender Document are non-refundable.
- 30. The total unit price, inclusive of GST, transportation, installation, Commissioning and all other charges, shall not exceed ₹25,000 per unit. The total estimated bid value is approximately ₹19,90,75,000.00 (Rupees Nineteen Crore Ninety Lakh Seventy-Five Thousand only).
