5. **Pre-Bid meeting** : A **Pre-Bid Meeting** for the “**Supply and Delivery of Pre-School Education (PSE) Kits (Toys)**” tender will be held on **16.04.2026 at 12:00 PM**.
6. The ICDS Directorate reserves the right to take the final decision on **whether to adopt bid splitting or to award the entire order (100%) to the L1 bidder**. In case bid splitting is adopted, the final order shall be distributed as follows: **L1 – 70% and L2 – 30%, subject to L2 matching the L1 rates**.
7. If any local bidder qualifies as L1 or is found eligible and agrees to match the **L1 price**, the work order may be awarded to such bidder in accordance with the provisions of the **Bihar Purchase Preference Policy (BPP)-2024**. In this case the **above clause (6) will not be applicable**.
8. After satisfactory delivery and successful quality verification, the **approved L1 price shall remain valid for a further period of two (02) financial years**. During this period, the Department may place the order to **L1 bidder at the same approved rates**.
9. The toys should be customized in accordance with the **regional culture, art, and moral values of the State of Bihar**.
10. The ICDS Directorate, Bihar, reserves the right to accept or reject any tender offer, or to cancel the entire tender process, without assigning any reason thereof.
