



17 01.04.2026	<p>Ld. Counsel for the Appellant and BIADA are present.</p> <p>Ld. Counsel for the appellant stated that this is a modification appeal. The allotment was cancelled on 07.12.2022 and restored on 12.01.2024. Appellant had surrendered 14,000 Sq. Ft. land out of the total allotted land and after receipt of surrendered value under Exit Policy, appellant was ready to start the work but due to fund crisis he has not started work onward, filed modification petition for extension of time. After getting amount from exit of part land in March 2025, appellant made some construction and machines were erected on the foundation.</p> <p>Ld. Counsel for BIADA stated that modification should not be entertained. Earlier the appellant had given undertaking that they will make the unit functional but they have failed to do so as per time frame and now seeking time extension. BIADA has conducted inspection on 04th June, 2024 accordingly unit was completely shut, electric consumption was zero and there was no machine.</p> <p>Appellant has stated that due to medical reason in family, there is some financial crunch, as and when maize will be available, he will make the unit fully functional.</p> <p>Ld. Counsel for the appellant stated that many of the</p>	

modification petitions have been heard and allowed by this Appellate Authority. We have filed this modification petition seeking extension of time, when time was expired.

Considering the arguments of rival submissions, it is observed that appellant should come to this Authority after cancellation or after issuance of any notice by BIADA. This petition is premature, hence, modification petition is disposed of with above observation.
