
Tender Reference No- 7P/Misc-06-04/2025/5737 dated 13.04.2026 for selection of agency for Implementation and Support of Tally based integrated Financial Management System for the three tier PRIs of Panchayati Raj Department, Government of Bihar, Patna which invites tenders from eligible and experienced agencies for the supply, customization, installation, deployment, training and support of a multi-user Tally Software based integrated Financial Management System :-

2	The benefits and provisions incorporated in Bihar Startup Policy 2022 and Bihar Purchase Preference Policy 2024 and Government of India's Startup India framework shall be to the present tender? (i) It will assist in ensure alignment with the applicable policy framework and facilitate broader participation. (ii) It will enable participation from a wider pool of capable and emerging entities.	The Bidder in pre-bid query requested applicability of benefits under the Bihar Startup Policy 2022 and Bihar Purchase Preference Policy 2024, including relaxation in eligibility criteria such as turnover and prior experience. The query was examined in light of the provisions of the said policies and the Bihar Financial Rules. It is clarified that while startup related policies encourage participation and provide conditional preferences, they do not mandate blanket relaxation of essential eligibility criteria. Considering the nature, scale and technical requirements of the work, the prescribed criteria are necessary to ensure efficiency, competition and quality of procurement. Accordingly, the request for relaxation was not acceded to, and the tender conditions remain unchanged. As per RFP.




