3. Project Description:-

The Water Resources Department, Government of Bihar, has initiated this ambitious plan to address the **Irrigation through pipe distribution network in Punpun Irrigation project to provide irrigation in a Gross command area 43,716 Ha with CCA 30,602 Ha.**

4. Scope of Work to be carried out.
 - i. Conduct environmental baseline survey of the project for the existing environmental components and collection of primary data.
 - ii. Study of the existing land use – land cover soil type and drainage pattern etc.
 - iii. Conduct broad survey of the existing ecology at project site.
 - iv. Collection of environmental data.
 - v. Obtain detail information/data for the area under submergence, population affected, demographic profile of the affected families including extent of various losses etc. required for preparation of a R&R plan.
 - vi. Environmental Impact Assessment report and Environmental Management Plan shall be prepared comprising of Mitigation measures & environmental safeguard measures.
 - vii. Environmental Monitoring Programme.
 - viii. Public Consultation/ Public Hearing.
 - ix. Environmental Cost Estimate & Analysis of Budget.
 - x. Preparation of pre-feasibility report.
 - xi. Obtaining Term of Reference from MoEF & CC/ SEIAA.

- xii. Obtaining Environmental Clearance from MoEF & CC/SEIAA.
- xiii. The Environmental Impact Assessment Report must be prepared in accordance with Approved ToR by MoEF & CC/SEIAA.
- xiv. The Consultant shall comply with observations/requirements/comments shared by WRD GoB and MoEF & CC/SEIAA.

 - ii. The Consultant have in house NABL accredited laboratory or exclusive MoU with NABL accredited laboratory.
 - iii. Average Annual Turnover (AAT) through Consultancy services in last three financial years i.e. 2022-23, 2023-24 & 2024-25 must be at least Rs. 2.5 Crore, duly supported by a valid audited Balance Sheet.
 - iv. The consultant must have completed minimum one Irrigation/River valley project and obtained Environmental Clearance from MoEF & CC/SEIAA.
 - v. The list of Minimum Key Staff are listed below. The consultant must furnish an undertaking for availability of the following key experts for execution of assignment in case of award of work.
