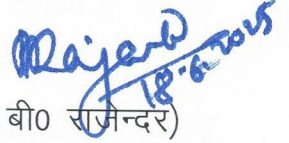

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Bihar hereby makes the following rules to regulate the recruitment and service conditions of Sports Trainer Personnel in the State Sports Academy and International Cricket Stadium, Rajgir under the Sports Department:-

1. **Short Title, Extent and Commencement.-** (i) These Rules shall be known as the "State Sports Academy And International Cricket Stadium, Rajgir Sports Trainer Cadre (Recruitment and Service Conditions) Rules, 2025".

(ii) It shall extend to the entire State of Bihar.

(iii) It shall come into force from the date of its publication in the Official Gazette.

2. **Definitions.-** In these rules, unless the subject or context otherwise requires,-

(i) "State Government" means the State Government of Bihar;

(ii) "Department" or "Controlling Department" means the Sports Department;



(iii) "Appointing Authority" means the Additional Chief Secretary/Principal Secretary/Secretary, Sports Department;

(iv) "Commission" means the Bihar Technical Service Selection Commission;

(v) "Cadre" means the Sports Trainer Cadre of the State Sports Academy and International Cricket Stadium Rajgir;

(vi) "Cadre Controlling Authority" means the Additional Chief Secretary/Principal Secretary / Secretary, Sports Department;

(vii) "Member of the Cadre" means a person appointed and included in the Sports Trainer Cadre for State Sports Academy and International Cricket Stadium, Rajgir.

(viii) "Appointed Date" means the date on which these rules come into force.

3. **Cadre Structure.-** (i) The structure of this cadre shall be as follows-

Sl.No.	Designation	Level	Status
1.	Sports Trainer	Basic Grade	Non Gazetted

(ii) All the posts of the basic grade of this cadre shall be filled by direct recruitment.

(iii) The pay scale/pay level of the post in this cadre shall be the same as may be determined/approved by the State Government from time to time.

(iv) This cadre shall be at the State level and the cadre strength shall be such as may be determined by the State Government from time to time.

4. **Qualification.-** (i) The minimum educational qualification for appointment to the basic grade post of this cadre shall be graduation degree from a recognised University.

(ii) The candidate should have passed Diploma in Sports Training in the relevant sport from National Sports Institute run by Sports Authority of India under the Ministry of Youth

Affairs & Sports, Government of India or Post Graduate Diploma in Sports Training (PGDSC) course from Lakshmibai National Institute of Physical Education, Gwalior or Central Sports University or equivalent qualification from a Sports University recognized by University Grants Commission or Bihar Sports University.

(iii) Sports Achievement - Represented the Country in Olympics /Commonwealth Games / Asian Games in the respective sports discipline or represented the State in recognized National Championship or participated at least twice in All India Inter University/Recognized Junior Championship/National Youth Championship or participated 03 times in Inter Services Competition/ All India Police Games /Inter Railway Championship.

(iv) The minimum age of the candidate shall be 21 years on 1st August and the maximum shall be the same as may be determined by the State Government (General Administration Department) from time to time.

5. **Selection Procedure.-** (i) The department shall calculate the available vacancies on 1st April every year and provide the requisition of available vacancies category wise to the Commission by 30th April.

(ii) On the basis of the requisition received, the Commission shall publish an advertisement for selection.

(iii) The procedure of determining the subject/interview and syllabus as per academic and technical qualification for the competitive examination to be held in the light of the advertisement shall be determined by the Commission in consultation with the Department keeping in view the syllabus of the regular course of Diploma in Sports Training of Sports Authority of India.

(iv) The Commission shall recommend Roaster wise candidate to the department as per the merit prepared on the basis of marks obtained in the examination and interview.

- (v) The candidates recommended by the Commission shall have to appear before the Medical Board constituted by the State Government. If the candidate does not fulfil the required physical s as prescribed by the Department for efficiently performing the official duties, the recommendation of the concerned candidate shall be cancelled.
6. **Reservation.-** For appointment to the cadre, the provisions of reservation as determined by the State Government from time to time shall be applicable.
 7. **Seniority.-** The inter se seniority of the newly appointed Sports Trainer Personnel in the cadre shall be as per the merit order as determined by the Commission.
 8. **Probation Period.-** (i) The members appointed on the basic grade of the cadre shall be on probation for 01 year. If the service is not found satisfactory during the probation period, it may be extended for 01 more year for reasons to be recorded. If the service is not found satisfactory even during the extended period, the service may be terminated.
(ii) During the probation period the newly appointed member shall have to successfully complete such training as prescribed by the Department.
 9. **Confirmation.-** The service may be confirmed after satisfactory completion of the probation period, completion of training as prescribed in the probation period and passing the Hindi Noting and Drafting Examination conducted by the Cabinet (Rajbhasha) Department.
 10. **Coaching.-** The members of this cadre may be sent for high level technical coaching of sports or national / international coaching camps or event experience within the State or outside the State / Country for a period determined by the State.
 11. **Residual Matters.-** In respect of subject or matters in which specific provision could not be made in these rules, the provisions in force for employees of equivalent level of the State Government shall also apply to the members of this cadre.

12. **Removal of Difficulties.-** Where in the opinion of the Government any provision of these rules causes undue hardship to any member or group of members of the Service, the Government may, in consultation with the General Administration Department, relax any provision(s) of these rules for the benefit of any member or group of members of the Service.
13. **Interpretation.-** Where there is any doubt in the interpretation of any provision of these rules, the same shall be decided by the Department in consultation with the General Administration Department/Law Department and its decision shall be final.
14. **Repeal and Savings.-** (i) All resolutions/circulars issued for this cadre before the appointed date are hereby repealed.
- (ii) Notwithstanding such repeal, anything done or any decision taken under the earlier rules/resolution/instruction shall be deemed to have been done or taken under these rules as if these rules were in force on the day on which such thing was done or such decision was taken.
