In exercise of the powers conferred by proviso to Article-309 of the Constitution of India, the Governor of Bihar is pleased to make the following rules to amend the Bihar Sub-ordinate Forest Service Rules, 2013:-

1. **Short title, extent and commencement:-** (1) These rules may be called the **"Bihar Sub-ordinate Forest Service (Amendment) Rules, 2026"**.

(2) It shall extend to the whole of the State of Bihar.

(3) It shall come into force on the date of its publication in the official Gazette of Bihar.

2. **Amendment in Rule-7 (A) of the "Bihar Sub-ordinate forest Service Rules, 2013."** The following Sub rule (v) shall be inserted after Sub rule (iv) of the said Rules:-

"(v)- For direct recruitment on the post of Forest Guard, 20 percent horizontal reservation of available vacancies shall be admissible to the ex-Agniveers after equally classifying them under unreserved category, economically weaker section category and reserved category. Benefit of this reservation shall be admissible to only those candidates whose permanent residence is in Bihar, i.e. who are native of Bihar. If ex-Agniveers are not available in fixed number then other available candidates for respective category may be selected against the remaining posts."
