In exercise of powers conferred by the proviso to Article-309 of the Constitution of India, the Governor of Bihar is hereby pleased to make following Rule to amend The Bihar Travelling Allowance Rule, 1949:-

Bihar Travelling Allowance (Amendment) Rule, 2026

1. Short Title, extent and Commencement: –

- (1) These rules may be called Bihar Travelling Allowance (Amendment) Rule, 2026
- (2) It shall extend to the whole of the State of Bihar.
- (3) It shall come into force on date of its publication in the Official Gazette.

2. After Note (vii) of Rule-69(1) of the Bihar Travelling Allowance Rule, 1949 the following note (viii) shall be added :-

"(viii) During travelling abroad, for official work, daily allowance shall be admissible at the rate prescribed by the Ministry of External Affairs, Government of India."
