No-6-N-11-08/2021.....2/3(6B).../ In exercise of powers conferred under proviso to Article-309 of the Constitution of India, the Governor of Bihar is hereby making the following amendments in the Bihar Nursing Cadre Rules, 2024 under the Health Department namely "Bihar Nursing Cadre (Amendment) Rules, 2026".

**1. Short title, extent and commencement.-**

- (i) These Rules may be called the "Bihar Nursing Cadre (Amendment) Rules, 2026".
- (ii) It shall extend to the whole of the State of Bihar.
- (iii) These amendment rules shall be deemed to have come into force with effect from 24.04.2025.
- (iv) These rules shall be published in the Official Gazette.

**2. Rule 2(viii) of the Bihar Nursing Cadre Rules, 2024 is substituted by the following:-**

"Recognized Institution" means an institution recognized by the Union or any State Government or any body authorized by it.

**3. Rule 6 of the Bihar Nursing Cadre Rules, 2024 is substituted by the following:-**

Qualifications, for appointment to the post of basic category through direct recruitment, minimum



educational qualification and eligibility will be required along with passing the GNM course of the duration determined from time by the Indian Nursing Council, New Delhi from a recognized institute along with the relevant certificate. Those having B.Sc (Nursing) qualification will also be eligible to apply. While applying, it will be mandatory for the candidate to be registered with any Union or State Nursing Council, but after final selection, it will be necessary to get registered with Bihar Nursing Registration Council, Patna before appointment/joining.
