

12 18.12.2025	<p>Ld. Counsel for the appellant as well as Ld. Counsel for BIADA are present.</p> <p>Ld. Counsel appearing on behalf of the appellant submitted an application for seeking extension of time for starting the commercial production and stated that the unit is for manufacturing of Transformer unit. He further stated that one of the Director of this unit is also a director of another unit and due to litigation with Bank his CIBIL score has been impaired by the Bank in the matter of that unit and due to this hardship they are facing difficulty in getting finance. They have already filed a writ petition against the Bank for the issue related to CIBIL matter and sought a time extension of six months for starting commercial production after disposal of the writ.</p> <p>Ld. Counsel for BIADA stated that earlier they have already been granted three times extension but no commercial production has been started. Even there is a dues of Rs.1.2 lacs against the unit and it is uncertain when writ petition will be disposed.</p> <p>After careful consideration of the facts of the case, in the interest of justice, six months' time is granted to the unit subject to payment of cost, which is as per a new clause of Land Allotment Policy passed in Agenda No. 5 in the 95th meeting of Board of Directors dated 10.09.2025, issued vide Memo No. 3894/Estt. Dated 25.09.2025.
