The Govt. of Bihar has established a three member Bihar Electricity Regulatory Commission (BERC) having a Chairperson and two Members. The Commission shall regulate the Electricity industry in the State of Bihar under the provisions laid down in the Electricity Act, 2003.

One post of Member of BERC is likely to be vacant, in the near future. A Selection Committee has been constituted in terms of the Electricity Act, 2003.

2. I am directed to invite proposals and nominations of candidates for consideration of the Selection Committee for post of one Member of the Bihar Electricity Regulatory Commission. The nominees should be persons of ability, integrity and standing having adequate knowledge and experience of, and have shown capacity in dealing with problems relating to Engineering, Finance, Commerce, Economics, Law or Management. U/S-84 of the Electricity Act, 2003.

3. The terms of appointment will be in accordance with the provisions of The Electricity Act, 2003 and include the following:-

(i) The person appointed would have to resign or opt for voluntary retirement from the service to which he/she belongs where he/she is currently serving.

(ii) The Member would hold office, for a term of five years from the date he/she assumes office and shall not be eligible for re-appointment in the same capacity in the Commission.

Provided, that no Member shall hold office as such after he has attained the age of sixty-five years.

(iii) Any Member in the Commission shall-

(a) Not accept any commercial employment for a period of two years from the date he ceases to hold office.

(b) Not represent any person before the Central Commission or any State Commission in any manner.

4. The pay of the post of Member carries of Rs. 1,82,200/- per month. The allowances payable and the other terms and conditions of service of the Member shall be as prescribed by the Bihar Electricity Regulatory Commission (Conditions of Services of Chairman and Member) Rules, 2003.



5. The nomination should contain the following:-

(i) Bio-data of proposed candidate containing the following details:-

- (a) Name
- (b) Age & date of Birth
- (c) Position presently held
- (d) Educational Qualification
- (e) Details of post previously held and experience in the relevant field.

(ii) Willingness letter to resign his/her present post to join Bihar Electricity Regulatory Commission (BERC), if selected.

(iii) A letter from the proposed intimating the details of any office, employment, Consultancy agreement or arrangement which he/she has in his/her own name or in any firm, association of persons of body corporate, or in the name of any relative, carrying of body corporate, or in the names of any relative, carrying on any of the following business, namely:-

- (a) Generation, transmission, distribution or supply of electricity.
- (b) Manufacture, sale or supply of any fuel for generation of electricity.
- (c) Manufacture, sale, lease, hire or otherwise, supply of or dealing in machinery, plant, equipment, apparatus or fitting for the Generation, transmission distribution, supply or use of electricity and,
- (d) Any entity providing professional services to any of the business referred to in clauses (a), (b) and (c) above.

6. The nominations as indicated above are to be sent by speed post/courier to the Secretary, Energy Department, Govt. of Bihar, Vidyut Bhawan-2, Jawahar Lal Nehru Marg, Baily Road, Patna-800021. The nominations may be submitted on or before 30 January, 2026 by 04:00 PM. Nominations received after this date shall not be entertained.
