**Eligibility Criteria:**

- a) Firm should be registered with ICAI with minimum Four years of existence from the date of proposal (copy of registration has to be attached).
- b) Firm should have Income Tax PAN (Copies has to be attached).
- c) Firm should have Minimum Two years' experience of Internal/Statutory audit work in the Social/ Rural Sector/Government Sector. (Relevant Proof to be submitted).
- d) The Firm should have never been indicted by any court of law or any regulatory body or any state/ central government agencies or blacklisted earlier (Self declaration on organization letter head to be submitted).
- e) Average Annual turnover/ revenue of the Firm should be at least Rs. 10 lakhs (Ten Lakhs) over the last three financial years 2022-23, 2023-24 and 2024-25. (Relevant Proof to be submitted).

### **Audit Fees and TA/DA:**

The institute of Chartered Accountants of India through notification dated 07<sup>th</sup> April, 2016 has issued following guideline for compliance by the members of the Institute:

*A member of the Institute in practice shall not respond to any tender issued by an organization or user of professional services in areas of services which are exclusively reserved for chartered accountants, such as audit and attestation services. However, such restriction shall not be applicable where minimum fee of the assignment is prescribed in the tender document itself or where the areas are open to other professional along with the Chartered Accountants.*

In light of the above guidelines prescribed minimum fees for the firms interested to be appointed will be consolidated amount including expenses on TA/DA will be **Rs. 24,000/- (Rupees Twenty Four thousand only) per year excluding GST if applicable**. Those Firms whose quotation for fee is less than minimum fee quoted shall not be considered.

Payment would be made on the basis of the invoice raised by successful bidder after submission of final audit report.

The prescribed Tender Bid must be submitted to Director, Pranjali, Public Health Engineering Department, Government of Bihar, PRANJAL Office, Plot No. 17, Patlipura Industrial Area, Patliputra, Patna or a place of work notified by the authority by 03:00 P.M. of 15th January, 2026 in two separate duly sealed envelopes one "Technical Bid" and Second "Financial Bid" contained in Single big size envelope duly sealed and superscripted as "Tender Bid for Statutory Audit"
