Subject: Request for Information under the Right to Information Act, 2005 regarding the
"Road Drain Raft" construction on NH 131 [Formally known as NH-106]

Respected Sir/Madam,

I, (Dr) Pamal, a resident of Motipur, Karjain Road, Motipur hereby request the following information under Section 6 of the Right to Information Act, 2005:

1. The reason for not filling the ditch excavated by IILFS Engineering for the "Road Drain Raft" along on NH-131 (Formally NH-106), Karjain Road, towards north Near crossing over on NH-27 & NH-131.
2. The time frame in which the ditch was excavated and the expected date of its completion, including the filling of the ditch.
3. The total length of Road Drain Raft/drainage that will be constructed as part of this project.
4. The current status of the Road Drain Raft/drainage construction, including any progress reports or updates regarding the work.
5. A copy of the quality lab report(s) related to the materials used for the "Road Drain Raft" construction.
6. The grade of cement & Steel used in the construction of the "Road Drain Raft".
7. A detailed list of all materials used in the construction of the "Road Drain Raft" system, including the type and quantity of materials.
8. Any documents or reports related to the work progress of the "Road Drain Raft" construction, including reasons for the delay in filling the ditch.
9. If any alternate arrangements or safety measures are being implemented to prevent accidents or hazards due to the open ditch.
10. Whether local residents will be required to fill the outer ditch of the "Road Drain Raft" or if this will be handled by the road construction department or by the contractor. I.E, **IILFS Engineering**
11. The government's Standard Operating Procedure (SOP) for Excavating, filling the ditch and managing "Road Drain Raft" during construction, and whether it is being followed in this project.
12. Safety measures that are being implemented to prevent accidents or hazards due to the open ditch.
13. Single Point for Contact from IILFS Engineering for this project.
14. Whether a grievance cell has been appointed by the contractor to address public safety concerns during the construction of the drainage system and, if so, the contact details and procedure for filing complaints or concerns. Also TAT(Turn Around time) to resolve the grievance.
15. How the NH wing decides whether the contractor has followed all safety protocols during the construction of the drainage system, and whether regular inspections are carried out to ensure compliance with safety norms.

16. Whether the public will be allowed to use the "road drain raft" for their domestic purposes. I.E sewage drain .
17. Will any connections be provided to residents living beside the road to connect their sewage drain to the "road drain raft", and what are the procedures for such connections?
18. What actions will be taken if the contractor does not comply with the prescribed safety measures during the construction of the "road drain raft"?
19. Whether any beautification will be done to the road drain raft after its completion, and if so, what kind of beautification measures are planned (e.g., landscaping, planting of trees, or decorative elements)?
