

Counsel for BIADA is present, no one appeared on behalf of Appellant.</p> <p>Under compliance of order i.e. dated 28.01.2025, BIADA inspected the unit on 28.04.2025 in presence of the representative of the Appellant, where a shed was found constructed on approx. 2500 sq. ft. and a frame for shed was also found on the site. It is also mentioned in the report that out of 10890 sq. ft. only approx. 2600 sq. ft. land is being used and rest of the land was vacant. Unit has not complied the order to start trial production within three months.</p> <p>Another inspection dated 22.07.2025 depicts that work was going in limited way and no further construction/progress were made by the appellant. It shows that Appellant is not interested in industrialization and just want to keep the land in his possession.</p> <p>It seems Appellant is not interested in pursuing his case. Therefore, this appeal is dismissed in default for non-appearance and non-compliance of order dated 28.01.2025.</p>
