

Ibrahim as a proprietorship firm for making gate, grill, steel almirah etc. After some time he inducted a partner Anil Kumar Mishra with a share of 49%. Later on the partnership was dissolved and the Appellant Md. Ibrahim has handed over his share to Anil Kumar Mishra. Application alongwith affidavit was submitted by both the partners to that effect with request for change of ownership from partnership to proprietorship under One Time Opportunity Policy, 2023 and in light of the same an office order was issued by DGM, BIADA, Motipur Cluster on 02.04.2024. Subsequently, the Appellant Md. Ibrahim assailed the above said order dated 02.04.2024 and filed this Appeal.</p> <p>It seems that Appellant is not interested in pursuing his case.
