Tender Notice

Sealed tender is invited from Registered firms/Companies/Public enterprises for annual subscription of GPS NAV Data Card for 04 Cessna 172 R Aircraft as per the following:-

1. Bid submission starts from **06.01.2026** Tender Schedule has been provided in Sl. No 9 of this Notice.
2. The tender must reach to Secretary, Civil Aviation Department, Patna, Airport on or before **27.01.2026 at 05:00 PM**, by registered post/speed post/courier or by hand only.
3. Bidders shall submit their offer in **two separate sealed envelopes** one as Technical Bid and other as Financial Bid. The type of Bid must be written on each envelope (Technical/ Financial Bid). These two bids shall be kept in another big envelope which should be sealed and subscribed as "**Tender for annual subscription of GPS NAV Data Card for Cessna 172 R Aircraft.**"
4. Along with physical submission of bids, bidders must also submit the 'Technical Bid' online through e-mail, with the subject line as "**Tender for annual subscription of GPS NAV Data Card for Cessna 172 R Aircraft.**" on the Email-ID: cadbihar@bihar.gov.in on or before **27.01.2026 at 03:00 PM**. Please number the documents with serial number on each and every page and do mention the total number of pages of bidding document.
5. **Technical Bid should contain the following:**
 - A. An undertaking in the form of affidavit on 100 Rupees stamp paper that the Company has not been blacklisted by any Public Sector undertaking/ Government Organization/ DGCA.
 - B. An EMD of Rs 50,000.00 (Rs fifty thousand only) in the form of Bank Draft issued by a Scheduled/ Nationalized Bank in India, drawn in favour of Bihar Flying Inst. C.A Department, Cabinet Secretariat Department, Patna.
 - C. Self-attested copies of GST registration and PAN details.
 - D. Income Tax return certificate for Preceding three Assessment years (2023-24, 2024-25 & 2025-26) of the bidder.
6. **Financial Bid should contain the following:**
 - A. Financial Bid should contain the rate of annual subscription charges, validity of the rate and Guarantee/Warranty period.
 - B. The quoted rate should be inclusive of all taxes, no other extra charge applicable or payable.
 - C. Rate should be quoted in Indian Rupees (₹) only.
 - D. Rate should be firmed and fixed inclusive of all taxes.
 - E. The quoted rate shall be for door delivery to the **Civil Aviation Department, State Hangar, Patna, Bihar**, inclusive of all taxes, with no additional charges applicable or payable.
 - F. Financial bid shall clearly specify delivery schedule and payment terms.
 - G. Financial bid shall specify the validity of quoted rates for a period of 120 days from the last date fixed for submission of tenders.
 - H. Evaluation of financial bid will be done on the basis of the quoted rate. Financial bid will be opened only of those bidders whose technical bid are found to be responsive and meet all specified requirements.
7. Security money of Unsuccessful bidders will be refunded immediately after final selection.
8. The Technical & Financial bid of the tender will be opened tentatively on **28.01.2026 at 3:00 PM** before the committee headed by Secretary, Civil Aviation Department, Bihar, Patna or by an officer so authorized by him before bidders/ authorized representatives.


