## Scope of Work :-

Providing Design, Drawing & Supply, Installation of necessary standard materials as per relevant BIS code specification and commissioning of Booster Pump, Motor and its necessary components including VFD, SCADA System as required for total discharge of 0.020 Cum/Sec through already laid Pipe. at Nature Safari GLSR on turnkey basis with observation, operation & Maintenance for three years for Supply of Gangajal from Sone Bhandar, Rajgir Sump to Nature Safari GLSR. Work also include Construction of Pucca Pump house (Area 50 sqm) as per CPWD norms.

## Terms and conditions :-

1. Any contractor registered with the Central Government/ any State Government or any PSU or an agency of International or National repute may participate in the tender but registration with Water Resources Department, Govt of Bihar will be essential after issue of Letter of Acceptance (LoA) for the work.
2. While participating in e-quotation process, the contractor shall have to get themselves registered to get user ID, Password and Digital Signature. This will provide them eligibility for access to the website [www.eproc2.bihar.gov.in](http://www.eproc2.bihar.gov.in) and to download/participate in e-quotation process.
3. (a) Bid processing Fee and cost of BOQ (non-refundable) is mandatory to be paid through online mode (e-payment mode) i.e. Internet Payment Gateway (Credit/ debit Card), Net Banking, NEFT/RTGS under e-Tendering/e-Procurement system.  
(b) As per letter no. 07/PMC/ विविध / 879 / 2012- पार्ट -II- 88 dated 29.01.2024 of WRD, GoB, Patna must be followed as,
  - (i) All documents related to tender will be accepted only through online mode, so it will not be necessary to submit hard copy of any documents.
  - (ii) EMD will be accepted through online payment or in form of bank guarantee. It will be mandatory for the successful tenderer to submit the necessary documents like all the affidavits (in original), Bank Guarantee (in original) before agreement.  
(c) EMD will be acceptable either through online mode (e-payment mode) or physical mode/ Manual payment system under e-Tendering/e-Procurement system.  
Under on-line mode EMD may be made through Internet Payment Gateway (Credit/Debit Card) Net Banking, NEFT/RTGS.  
Under Physical mode/ Manual Payment System, Earnest money duly pledged/ endorsed to the **Executive Engineer, Irrigation Division, Biharsharif** should be in following shapes or combination thereof: -  
As per direction of Departmental Lt. No. 01PMC/विविध / 879 / 2012 पार्ट-II-804 dt. 19.10.2023 an unconditional Bank guarantee (As per SBD Format) from any Nationalized / Schedule Bank for the (120+45 days = 165 days) issued in favour of Executive Engineer, Irrigation Division, Biharsharif (If issued from any bank outside state then it has to be converted to any Nationalized/ Schedule Bank within state before the Agreement).  
It is mandatory that above mentioned instruments in the form of Earnest Money should be pledged / Issued in between the date of NIT and the last date of uploading the tender, otherwise the Bid will not be treated as valid.
  - (d) "Bids along with necessary online payment must be submitted through e-Procurement portal [www.eproc.bihar.gov.in](http://www.eproc.bihar.gov.in) before the date and time specified in the NIT. The department doesn't take any responsibility for the delay/Non Submission of Tender / Non reconciliation of online Payment caused due to Non-availability of Internet Connection, Network Traffic/Holidays or any other reason."
  - (e) BSEDC Processing Fee and Tender Fee/BOQ Fee has to be paid through e-Payment mode only. EMD may be paid either through online or offline mode."
4. Bidders/Contractors can access tender document on the above mentioned website, fill them and submit the completed tender documents as Electronic Tender on the website itself only. It is

- mandatory that all important documents for tender i.e. Earnest Money / all certificates should be scanned & attached with e-tender.
5. Corrigendum/Addendum/Corrections, if any, will be published on the website only. The undersigned reserve the right to cancel/extend the tender without any prior information or without assigning any reason.
  6. The bidders should list up and imprint serial no. of scanned documents before uploading, so that, the particular documents can be located fast on the basis of Serial no. /Page no. All documents must be uploaded on PDF, MS Office (Compatibility Mode), JPEG, ZIP format. Claims will not be entertained for the uploaded documents in other format if it cannot be downloaded / opened.
  7. The bidders should fully satisfy themselves with the Download ability/Visibility of scanned uploaded documents.
  8. No claim will be entertained on account of disruption of internet service being used by the bidders. Bidders are advised to upload their bids well in advance to avoid last minute technical snags.
  9. Price Escalation – no price escalation will be entertained.
  10. Vague and conditional quotation will not be entertained.
  11. Acceptance – the authority reserves the right to accept/cancel or reject full or part of the quotation without assigning any reason for which no claims will be entertained.
  12. The bidder will furnish the details of their past performance regarding this nature of work with relevant proof.
  13. It is desirable that the work site should be visited by the interested quotationer on any working day before submitting the quotation.
  14. Bidders should quote the rate and amount for supply, Installation, Testing, Trial run and service inclusive of all applicable taxes & duties G.S.T. i.e., packing, freight & insurance, etc.
  15. Accommodation and transportation for person to be posted for installation and data monitoring will be borne by the bidder.
  16. The watch & ward and protection from being damage of the laid cables, equipment will be the responsibility of bidder.
  17. Defect liability period for All equipment and allied fixtures will be 03 years from the date of commissioning.
  18. Bidder should submit an affidavit that all terms and conditions are acceptable.
  19. Tender decision will be done as per the provisions contained in the updated Circulars / Letters issued by Water Resources Department and other concerned department of Govt. of Bihar.
  20. One percent cess for building & labour welfare will be deducted from the contractor's bill as per rule. Also, in the light of government circular and order, GST, IT, Royalty and any other tax will be deducted from the contractor's bill as per rules. Payment will be processed in case of up to date GST (GSTR-3B) filling must be cleared at the time of payment.

  24. In case of more than one successful bidders having same minimum quoted rate, successful bidder will be decided by lottery system as per guide line of Bihar PWD code.
